

Shene militants surrender to **ENDF at Raya** front

ADDIS ABABA - Members of the terrorist Shene militants have surrendered to the Ethiopian National Defense Force (ENDF) at Raya war front while supporting their senior partner in crime, TPLF.

Earlier, both terrorist groups, Shene and TPLF, announced their agreement to work together to destabilize Ethiopia when the latter wreaked havoc on the Amhara and Afar states. Committing aggression by both states, the radical factions have committed various atrocities, especially civilian massacre.

Approached by the Ethiopian Press Agency (EPA) reporter, Shene members who joined the terrorist group from the Bati Front noted that the T-TPLF had employed them as the instrument to quench its thirst for political power. After the invaders were eliminated from Amhara and Afar states, those militants had been taken to Tigray to get military training.

Evidence shows ICHREE chair's ties with T-TPLF enablers

ADDIS ABABA - Various items of evidence have confirmed that the International Commission of Human Rights Experts on Ethiopia (ICHREE) Chair Kaari Murungi has been a hardline supporter of Terrorist

Now, she is also toiling on whitewashing T-TPLF's crimes in broad daylight having led the ICHREE, so stated twitter campaigners.

In his twitter message, Nafyad Wakjira indicated that Murungi has been never exposing crime against humanity committed by the terrorist group in the northern conflict and not stated the effort of the Ethiopian government forwarding on peace option.

The campaigner further stated that Murungi has always been disseminating false information drawn from the terrorist TPLF propaganda and some global paid media. For instance, she tweeted: "Ethiopian troops and militia rape, abduct women and girls in Tigray conflict" that derived from Amnesty International as a source.

Ethiopia's ABABA-Implementation of Sekota Declaration is a model for other nations and that would soon be implemented in six other African nations, African Development Bank (AfDB) said.

During a high-level presidential dialogue on nutrition, AfDB President Akinwumi Adesina (PhD) praised Ethiopia's government for its success in putting the Sekota Declaration into practice, and "it could serve as a model for other nations."

The Ethiopian government and the AfDB hosted a high-level presidential dialogue on nutrition to encourage collective action by African leaders to end childhood stunting, boost human capital, and promote development while sharing Ethiopia's experience in implementing the Seqota Declaration.

Addis raises over 160 mln Birr for **GERD**

. Contributes over 3.6 billion Birr since commencement

ADDIS ABABA -Individuals and businesses in the capital Addis Ababa have contributed over 160 million Birr for the construction of the Grand Ethiopian Renaissance Dam (GERD) during the past two months, the Public Participation Office disclosed.

The Office of Public Participation Coordination Project of the GERD Construction in Addis Ababa further stated that some 3.6 billion Birr has been secured from various income generating schemes in the capital for the iconic dam.

The Office General- Manager Misker Negash told the Ethiopian Press Agency (EPA) that the closer partnership they have established with the Commercial Bank of Ethiopia (CBE) and other stakeholders enabled them to amass a significant resource from the public. Also, the commitment of government and nongovernment agencies, the public at large as well has played a pivotal role for the

The successful completion of the mega hydroelectric dam would have a paramount importance for the nation and enable the latter to thwart the conspiracies of historical enemies and solidify the public's unity. The dam has also guaranteed the right of fair utilization of the Nile waters among riparian countries.

Commended the continued financial support from Ethiopians for the construction of the grand project and other development activities back home, Misker called on the public to support the building of the dam financially, professionally and in other ways. ADDIS ABABA-KOICA Ethiopia Office has provided various materials and nonmaterial supports to Kechene Women and Children Care and Rehabilitation Institution (KWCCRI).

In collaboration with Addis Ababa Women, Children and Social Affairs Bureau, the office handed over material supports yesterday to KWCCRI in the presence of representatives of the office and various government officials.

Likewise the office has provided training on Gender-based Violence and psycho-social support for employees of the institution and bureau to enhance their capacity on gender based violence and ways to provide psycho-social support for abused women and children.

The office has donated 5,000 packs of sanitary pads, 200 bath soaps and 200 laundry soaps along with the cost of training the office has provided a supports worth value of 380,000 Birr.

Speaking at the handover ring of the materials and launching of the training event KOICA's Deputy Country Director Kim Sun Young said that KOICA has been addressing a number of socio-economic problems through the KOICA-club support program under its fellowship program. The KOICA established the club to facilitate the exchange of knowledge, skills, and experience among Ethio-Korean alumni members and contribute to the social services in Ethiopia.

The club was established back in 2001 with



the support of KOICA's Ethiopia office with fellow participants of its short and longterm capacity-building program.

In their professions and skill along with KOICA's budget support members of the club has been reaching out to the core community problems since its establishment.

She stressed that the club has been widely involved in post-COVID-19 and conflict responses adding that the club has been conducting National Dialogues on the impacts of the pandemic and conflict and, vulnerable women, children, and elders support associations have been supported in awareness creation training and different material donations.

KWCCRI Manager Turuwork Debebe told The Ethiopian Herald that her institution needs a lot of supports from donors to rehabilitate women and children who join her institution because of various social problems.

She stressed that the institution have been providing different educational, psychological, medical and other supports for female children that have joined the institution because of lack of family and other problems.

She underscored that currently the institution has been providing total institutional care and supports for 117 female children.

Is ICHREE's 'report' to obscure TPLF's grievous atrocities?!

Some sanctimonious countries that fall in the set referred to the conceptual west by Pan Africanists are in a frantic bid to saddle their subtle political agendas on Ethiopia and to dictate such schemes to it under the guise of protecting human right violations.

They have dished out a wrong narrative via an International Human Rights Commission of Experts (ICHRE), whose very inception is highly dubious after the International Human Rights Commission and the Ethiopian Human Rights Commission had jointly exposed the bellicose and sanctimonious nature of the mendacious TPLF.

It is a public knowledge that the narrative is churned out to give a kiss of life to terrorist TPLF, as a last ditch effort with bulging eyes, that is clamoring for elixir scouring the sky of hypocrites.

Worse still, the study is one that has gone off the track as it is completely divorced from a scientific method of conducting a reliable research. It was largely based on hearsays. It was a narrative which did not take aboard pertinent bodies or was one that deliberately brushed aside concerned parties. As such, it was outright rejected as a fallacious chronicle.

The make-believe or fictitious report blindly tilted the balance towards the mourning-killer. It bald-facedly tried to twist the incumbent's arm. These drag into light the report's appalling untrustworthiness. This sours or heavily damages the report's credence.

The report barefacedly claims the government has used starvation as a weapon of war to swap the subject of the discussion turning a blind eye to the glaring fact that TPLF was ferrying food aid to its trenches, and using it for bartering it with arsenals. It underplays the long distance the government went to outreach people of Tigray even allowing a unilateral cessation of hostilities.

The report bristling with groundless accusations is one prepared on purpose to extend a helping hand to terrorist TPLF that serves a reliable Trojan horse to hypocrites and their tail organizations and countries.

To tell terrorist-TPLF character is untoward all times, it simply suffices to check its checkered past.

What hypocrites need remind themselves is one-size-fits-all formula could not be applied all time. Ethiopia is a country that stood shoulder high foiling subjugation by self-seeking supremacists and colonizers. Hence, they could not make Ethiopia a pawn as their former colonies using Trojan horses like the hideous, blood thirsty, treacherous, treasonous, and siding the merciless and chatterbox TPLF, Ill-famed by negative association they are rather blemishing their own image.

Ethiopia could not accept a wrongheaded report. Nor could the discerning ones for that matter!

Tigrayan opposition should voice louder about Tigrayan mothers, youth, and children

o far, no one comprehends that the people of Tigray have been paying unnecessary sacrifices only for safeguarding the power of T-TPLF officials since the inception of the party. The group was initially established to resist the dictatorial rule of the then-military Derg regime. However, it replaced that military regime and rather resumed a somewhat similar mode of despotic rule throughout the country.

The undemocratic group is known for its war-mongering behaviour as it is not able to respond to public queries instead. The blind group which has no public trust has been now and then forcefully pushing the people to be involved in endless war. If they will not lose the power and the benefit, the group of T-TPLF has no worries about the increasing death of civilians especially children and women during the time of war.

Even though they have not obtained the ears of international organizations, some political party members are now and then trying to be the echo of the Tigray people who have been oppressed for a long. The Terrorist TPLF's triggering of another round of war is a genocidal attempt to destroy the remaining people of Tigray, ethnic Tigray politicians. The criminal faction is committing war crimes by recruiting underage children and the elderly.

The renewed conflict is a clear indication that the T-TPLF continues to believe in a military solution and fully disregards the plight of innocent civilians. The terrorist enterprise is forcibly conscripting the Tigray youth for another round of aimless and destructive war to quench its thrust for political power, said Tigray Democratic Party (TDP) President Aregawi Berhe (Ph.D).

It is visible evidence that those children are not even able to hold the weapon given to them, let alone fight with the Ethiopian joint forces. Apart from using children as cannon fodder, the T-TPLF continues committing atrocious crimes on the civilian population of Amhara and Afar.

The radical clique incited another round of war and ordered the people of Tigray including children, elders and others to join the war efforts simply to eliminate them from the earth said Nebiyu Sehul-Mikael, former Head of Prosperity Party's Office in the Tigray State.

The intention of the T-TPLF is merely to destroy the existing generation of Tigray and they have no care for the well-being of civilians under their control. The recent call-for-arms is a failure sign of the group's ill-conceived aim.

From the beginning, the war is incited by the leaders of the radical element and their close associates who could benefit from the situation and it is not in the interest of the people of Tigray. The war is not public; rather it is the interest of a few elites to achieve their hidden interest and that is why they are engaged in forceful conscription of underage children and the elderly.

Industry Group covers 850 hectares of fallow land by crop plant

• Expects to harvest 30, 000 quintals of wheat

ADDIS ABABA - Ethiopian Sugar Industry Group said it has covered 850 hectares of sugar factories' fallow land by crop plants alongside with its main activity of production of sugar cane.

On Thursday, the media team visited summer time wheat and other crops production activities of Wonji Shewa Sugar Factory.

Briefing Journalists, Industry Group Director General Wayo Robba said that as part of the national plan ensuring food security and generating foreign hard currency, it expected to harvest over 30, 000 quintals of wheat and other crops products from the current summer season.

It covered 850 hectares of land by different crop plants alongside producing plant

cane. Previously, about ten percent of the factories fallow land was uncultivated every year.

Different plants which increase the fertility of the fallow land were planted. However, this year uniquely, factories shifted to plant and develop wheat, maize and other crops to support food self-sufficiency and generate hard currency. This effort will contribute to the demand of basic seeds and food self-sufficiency activities of the government, he said.

In addition to the production of sugar and its input sugar cane, sugar factories have been developing basic crop seeds. Currently, the group has been aggressively working to expand and increase the production of crops in factories on fallow land, he added.

Representing Wonji Shewa Sugar Factory, Jemal Aman for his part said that the factory has expected to harvest over 30,000 quintals of crop this summer season alongside the production of sugarcane. It has done without harming the production of sugar cane. The factory simply utilized the fallow land which left any seed coverage. Various stakeholders such as Ethiopian Agricultural Works Corporation and others are supporting supplying fertilizer, seed and other inputs as well.

"This summer season, we acquired adequate lessons to strengthen our future wheat and other crops production activities. Over the past 70 years, Wonji Shewa Sugar Factory's fallow land was left uncultivated."

Ethiopian Agricultural Works Corporation Corporate Operational Sector Deputy Director Feleke Gezahegn said that the Wonji Shewa Sugar Factory is ready to harvest wheat and other crops which will cover 20 hectares of land. This will play an important role in addressing basic and certified seeds supply problems.

can solve the issue of child stunting in Africa. This project will receive four billion USD from the bank."

At the event, Deputy Prime Minister and Foreign Minister Demeke Mekonen said: "In order to ensure that the declaration serves its intended purpose; top management has been closely monitoring and supervising its implementation."

Additionally, he said that the Sekota Declaration is assisting mothers and children in getting nourishing food; it will be fully implemented by 2030. And the declaration aims to end child stunting in the nation.

The Deputy Prime Minister and Foreign Minister outlined four crucial actions that improved the Sekota Declaration's outcomes: political leadership and budget allocation, financial and technical support from development partners, implementation of problem-solving techniques, and gender-based feedback.

As to Demeke, over 110,000 children were saved in the Amhara and Tigray states within six years of the implementation, according to a study on the Sekota Declaration's implementation mechanisms that John Hopkins University had conducted.

By making nutrition a top national priority and establishing effective multi-sectoral nutrition programs in each of their respective nations, African Heads of State, the African Development Bank Group, the African Union mission to the United Nations, and partners pledged to invest in and accelerate progress toward ending stunting on the continent.

Hijra Bank introduces inclusive digital service

ADDIS ABABA- Hijra Bank, one of Ethiopia's full-fledged non-interest banks, introduced yesterday the up-to-date and inclusive digital banking service dubbed "Hijra Digital."

Speaking at the service launching event, the Bank President Dawit Keno stated that Hijra has employed the Omni Channel technology that incorporated all the digital banking services.

The president further highlighted that the new technology replaced the existing multichannel approach and gives the mobile, internet, card, ATM, POS and RTGS services in one. By avoiding the burden of remembering multiple passwords of the respective services, the technology enhances customers' experience.

Also, the Omni channel ensures quality services to customers in multiple platforms including internet, mobile and card and address the incongruence that could create between different channels.



Noting customers have pleaded repeated concerns about the existing logo's similarity with another bank, Dawit indicated new logo introduced in a bid to better represent Hijra's philosophy and distinguish the firm from fellow financial institutions.

Hijra Bank Board Chairman Mukemil Bedru said for his part that the bank's introduction of digital service is aligned with Ethiopia's digitalization strategy and helps the country to achieve digital transformation. Significant attention has also been given to ensure physical branch expansion to ensure the benefits of the rural community.

Though multi-channel is cheaper compared with Omni channel in terms of cost, Hijra opts to the latter with a view to providing first-level digital service to the growing customers, Mukemil elaborated.

Established in 2020, Hijra's paid up and registered capital has reached 980 million Birr and 1.26 billion Birr respectively and it has 42 branches spreading across the country. The bank has been mainly providing Wadiah, Kerdand Mudarabah as well as Murabaha type of the interest-free services.

Read all about it: Political hit job of International Commission of Human Rights Experts on Ethiopia exposed!!

he weaponization of the International Human Rights Commission by the TPLF's Patrons/Partners-in-Crime is finally exposed.

The "report" is a political hit job with the singular aim of shamelessly demonizing the Ethiopian Government and the Ethiopian National Defense Force, Militia and Fano, and canonization of the terrorist TPLF.

The Report mentions ONE and ONLY one human rights violation committed by the TPLF terrorist group in its investigation!

The main "conclusions" quoted directly from the "REPORT" are as follows (boldface added for emphasis)

Commission finds reasonable grounds to believe that the ENDF shelled Mekelle on 28 November 2020, killing and injuring civilians and striking civilian objects days after Tigrayan forces had left the city with their assets. ENDF soldiers committed widespread extrajudicial



killings, rapes and other forms of sexual violence, and looting during the sevenmonth period stretching from 28 November 2020 to 28 June 2021. ENDF personnel also used civilian objects for military purposes and restricted access to medical treatment.

The Commission finds reasonable grounds to believe that Tigrayan forces killed civilians and persons rendered hors de combat, raped, looted, and damaged or destroyed civilian infrastructure and property in Kobo and Chenna in late August and early September

The Commission finds reasonable grounds to believe that the ENDF conducted a drone strike against the Dedebit IDP camp on 7 January 2022, killing and injuring approximately 60 civilians and destroying civilian infrastructure. It also finds reasonable grounds to believe that there were no soldiers or military equipment in or near the camp on the day of the attack.

The Commission finds reasonable grounds to believe that the ENDF, EDF, and Fano have committed widespread acts of rape and sexual violence against Tigrayan women and girls. In some instances, the attackers expressed an intent to render the victims infertile and used dehumanizing language that suggested an intent to destroy the Tigrayan ethnicity. Tigrayan Forces have also committed acts of rape and sexual violence, albeit on a smaller scale.

The Commission finds reasonable grounds to believe that the Federal Government and allied regional State governments have implemented a widespread range of measures designed to systematically deprive the population of Tigray of material and services indispensable for its survival, including healthcare, shelter, water, sanitation, education and

What does the African Continental Free Trade Agreement hold for women?

Agnes Opus sells cereals in Busia, the border town between Kenya and Uganda. This is her lifeline through which she caters for her immediate family's needs from school fees to housing and medical care and support to her extended family. While she dedicates all her energy and time to this work which she loves, she struggles to meet all her needs. She faces many non-tariff barriers including harassment by officials and unclear and ever-changing information on trade requirements.

Agnes' challenges are not unique to her. They represent the plight of millions of women across the continent engaged in crossborder trade. They have expectations that the Women and Youth in Trade Conference and the adoption of a Women and Youth protocol by the African Continental Free easy for women to trade.

The AfCFTA holds great potential by creating the largest free trade area in the world by number of countries -55 - it connects, bringing together 1.3 billion people and a combined gross domestic product (GDP) valued at US\$3.4 trillion. The Women and Youth in Trade conference, hosted by H.E Samia Suluhu, the President of Tanzania, and the AfCTA secretariat aims at helping the AfCFTA work better for women and youth.

The continent has the highest rate of female

entrepreneurs globally with approximately 26% of female adults involved in activity entrepreneurial contributing between US\$250 and US\$300 billion to African economic growth in 2016, equivalent to about 13% of the continent's

Despite this potential, women earn on average 34% lower profits than men. Structural barriers like the ones faced by Agnes hamper the growth of womenled or owned businesses. These barriers include discriminatory legal and customary frameworks and practices, gendered stereotypes, norms and biases, and an unequal distribution of unpaid care and domestic work. Together, they prevent the full and equal realization of women's rights and their full, equal and meaningful Trade Agreement (AfCFTA), will make it participation and leadership in the economy.

> To see real progress, the protocal should focus on ending these barriers through four strategies.

> First, move beyond the mere signing of a protocol to implementable frameworks in each country. As an example, governments should pass legislations on preferential procurement that mandates the selection of services, goods or public works from women-led or owned enterprises and businesses that have gender-just policies and practices for employees and supply

This would be a game changer. Today, only 1% of current public procurement spending of US\$286.3 billion (15% of GDP) in Sub-Saharan Africa goes to women-owned businesses. Evidence shows that if the amount of public procurement spending to women entrepreneurs were doubled, that would be US\$5.7 billion while gender parity in public procurement would have women entrepreneurs in Sub-Saharan Africa receive over US\$143 billion in contracts from governments.

Second, governments need to facilitate trade not only in sectors where women are the majority, but to also support women to enter sectors where they are underrepresented. Sectors such as manufacturing, construction, and IT technology are some of the fastest growing sub sectors in the continent, yet women remain underrepresented.

In Kenya, where the construction sector is fast-growing, only 15.4% of registered contractors are women. Removing the barriers that face women in these sectors, including social acceptance, sexual discrimination, sexual harassment, and labor conditions including unequal pay would be a game changer.

Third, governments need to address the Non-Tariff Barriers (NTBs). NTBs are considered neutral measures with gendered impacts. Women face specific constraints that undermine their economic activities,

access to technical information and finances, and are often subject to harassment and extortion at borders.

They have less access to key trader networks and information about relevant procedures. Additionally, time-consuming measures and documentary requirements impinge more heavily on women. Addressing these should be part of a broader process for gender responsive trade policies.

And finally, there needs to be evidencedriven accountability mechanisms to track progress of the implementation of the new Women in Trade Protocols. Sex disaggregated data of trade volumes, gender indicators that track women's engagement in Africa as well as a score card that shows how countries are doing is needed.

The CCADP indicator framework and score card that tracks country implementation of the Malabo Commitments is an example of how data can be used to bring accountability to continental commitments integrating key gender indicators.

Challenges the construction sector encountered, the way out

The Ethiopian Construction Industry is categorized as weak sector in which for the last 20 to 25 years its role in the economic growth has been eroded and crippled by multifaceted problems, announced by the government.

Recently, when the meeting organized by the Addis Ababa Trade Sector Association Council took place here, the State Minister of Urbanization and Infrastructure, Engineer Wondimu Seta said that, though the contribution of the construction sector to the Gross Domestic Product (GDP) reached to 19%, the sector suffers from various shortcomings.

As to him, the problems arise from the policy that the sector is governed by. The national construction policy was introduced in 2006. However, after it was implemented improvement based on the changeable situation of the sector and evaluating of its effectiveness was not conducted. "On the one hand, the policy is neglected by many pertinent stakeholders and secondly, it was not evaluated and the necessary attention was not paid on it. As a result, no one can dare to say that the sector has been effective to meet its goals as it was expected" the Deputy Minister said.

Rules helpful for the implementation of the policy have not been introduced. The already existed directives also do not go in line with each other as the result, the sector remains dysfunction. Efforts were exerted to strengthen the sector by allowing foreign companies to come here and work but the venture faced challenges.

He further said that, the government's intention of inviting foreign contractors was in order to bring helpful knowledge here and experience sharing not just simply to engage in an ordinary infrastructure construction.

With regard to capacity gap between the local and foreign contractors, he said that in the aspect of finance the foreign contractors have more than the local contractors and engaged in many construction activities.

Currently, 79 projects are conducted by local contractors but looking in terms of finance, the local contractors owned only 45% allocated on the sector. Most mega projects are conducted by foreign contractors.

In the earlier times of the past 20 and 25 years, the participation of foreign contractors in the sector was insignificant but in the last 10 years their participation has been increasing. As to the State Minister, even though foreign companies engaged in construction work here, the role of the local contractors was not worth mentioning. They engaged in big projects but mostly on digging grounds and works which need only small level technology which does not upgrade their engineering skills.

Therefore, the aspiration to attain technology and knowledge transfer can be said unsuccessful. Currently, problems are witnessed in relation to the foreign contractors working activities and in this regard some contractors showed reluctance in employing



local professionals.

In the beginning, when the road construction project was planned employing local professionals for foreign contractors was an obligatory. Particularly when they win a bid to execute mega projects, they had a duty to employ fresh university graduates. After getting plenty of experiences the employed graduates had left the foreign company and started their own construction projects but now local professionals are giving up the sector because of the above mentioned reasons.

The invitation of foreign contractors to engage in various construction projects had various objectives and among others building the sector capacity, attaining technology transfer, sharing knowledge. However, it was not achieved as it was expected. The other problem the sector faced mentioned by the Deputy Minister is that poor coordination of the sector with the other pertinent institutions, allocating insufficient budget to the projects and the unavailability of plenty of inputs and these and other problems hampered the sector not to play its part in supporting economic growth.

As to the State Minister, the other challenge which should not be denied is that the uneasiness relation among the project owners, contractors and consultants. Had there been good relation, the sector would have achieved beyond what it was expected and problems of the sector would have been resolved.

Though they are the major stakeholders, the three entities instead of cooperate each other, they are going against each other. The inconvenient working environment among the three stakeholders compromises the quality of construction.

He further said that the uncooperative relation witnessed there made construction works bellow the standard and lag behind construction works accomplished centuries ago.

Hence, unless it is redressed, the consequence will be dire. The other factor responsible for the low quality of construction is employing poorly trained contractors and consultants. On the other hand, the poor quality education provided by colleges can be said hampers the sector's growth directly.

As to him, in Ethiopia, more than 45 thousands professionals graduate annually in engineering and related fields but there is

no graduate which properly produce design, inspect quality and manage the project. Leveling professional's standard only by experience also posed problems and did not add value on the sector. In this regard the level of contractors and consultants can be categorized in similar manner.

Currently, with no sufficient knowledge and experience, anybody can join the profession and if selection is carried out only few of them can transform the sector. As to Engineer Wondimu, currently there are 22 thousand registered contractors and consultants but only 2000 of them are better qualified and deliver as per the sector required.

It is unknown that, whether there is strong construction company with plenty of capacity which can be inherited by the family's grand children. When working license is provided by the pertinent government institutions to the contractor or consultant the criterion to be fulfilled is only to have machinery and workers and such procedure does not upgrade the sector's capacity and the quality of the construction works.

There are also contractors who did not engage in the construction work for the last ten years but could renew license in which they use the license for illegal practices. Therefore, to redress the malpractices prevailed in the sector, strong action must be taken and new system also must be introduced. As it is known previously in the system there was no reward for good worker and punishment for guilty.

As to him, unless intergenerational companies are created, cutting age technology is introduced and progress is registered, transforming the sector is unthinkable.

As to the State Minister, his office will strive to take various measures to tackle the problems witnessed currently. As it is known, Ethiopia aspires to reach to the middle income country in the coming 10 years. Hence, unless the sector's problems are resolved, attaining the goal is unrealistic.

All sectors of development endeavors demand the construction industry involvement that is why priority must put in place for tackling the construction sector challenges.

Currently, the dwindling supply of cement hampered the construction activities and worse to this, even renewing old house is impossible. It is common to see that retailers selling cement by piece of kilo. The price of cement has been more expensive than any other country in the world. Many speculate that the cement product has been expensive due to shortage of products and others said that it was because of artificial shortage; again others suggest that due to weak capacity of cement factories but as to the deputy minister, all are not the true cause of the cement shortage.

As to him, one of the indicators of economic growth measurement is per capita consumption of cement. Currently, based on the nation's economic development the nation per capita cement consumption is at least 500 kilogram annually. Let say Ethiopia is with 100 million population and based on this number the nation has to produce 50 million tons of cement product annually. Nevertheless, currently the cement factories in Ethiopia have the capacity to produce from 16 to 18 million tons of cement annually. When the product is divided to the whole population, the annual per capita consumption would be 75 kilogram.

Therefore, if it is needed to achieve economic growth, resolving the problems which hamper the construction sector is essential. In addition, substituting the imported cement product is vital.

Due to shortage of construction inputs, the private sector is unable to exert its energy with full capacity and the government projects are also stranded, and individuals are unable to do their own construction. However, it is clear to understand that, Ethiopia has sufficient raw materials which reaches up to 98% for cement production the nation needs which enables not only to meet its local demand but also for export to the neighboring countries and to the Middle East. However, it suffers from shortage of the product.

The State Minister traced back the rootcause of the scarcity of cement products and as to him, the decision taken by the government five years ago can be said the root cause. That time the government inhibited providing license to new investors who showed interest to involve in cement production assuming that the existing cement factories have been producing sufficient products that meet the demand. However, five years later the bag of cement which was sold by 280 birr reached to 2000 birr in which alarmingly sky rocketed.

The decision made by the government that time was only to serve the interest of few individuals rather than the public by blocking other investors no to enter in the cement business.

Consequently, the shortage of cement products has been aggravated and currently the cement factories produce only 1/5th of the nation's annual demand. Therefore, one should not be surprised by the shortage of supply witnessed today. As to the Deputy Minister, among the various problems witnessed in the sector organizing and disseminating information is one of it. Information with regard to how many construction works have been completed and their outcome is not availed. Therefore, he said that, his ministry is resolute to resolve the mentioned problems.





perpetrating unspeakable crimes against the people of Afar and Amhara, the disgruntled group has been moving heaven and earth to tarnish the image of the country. In spite of this reality, the report fails to expose the nefarious deeds of the ragtag group.

Ethiopia's Permanent Representative to the UN in Geneva Ambassador Zenebe Kebede stated that the conclusions of the "report" are self-contradictory and biased which doesn't pay attention to the T-TPLF's atrocities in Afar and Amhara states. "We have no option than to reject this report, as we have rejected the resolution that established it and the very establishment of this mechanism as well."

Noting the government's commitment to collaborate with any human rights mechanism founded on a genuine objective of protecting human rights, the ambassador indicated there is no any single evidence that shows government's weaponized of starvation. "We questioned the legitimacy of establishing the expert commission because the purpose of the establishment was to reinvestigate what has already been investigated by the Office of the High Commissioner and the Ethiopian Human Rights Commission jointly."

"We will never cooperate with the established mechanism and we decided to engage with the expert commission to discuss modalities of cooperation if they are ready to take into account the concerns of Ethiopia and focus on what has never been done rather than repeating what has already been done."

He further stressed that the UN Human Right Council unanimously endorsed the joint investigation and recommended the Ethiopian government to conduct a criminal investigation and ensure accountability. Accordingly, the Ethiopian government immediately established an inter-ministerial task force to facilitate the investigation task.

The government requested the Office of the High Commissioner including the President of the Human Right Council to investigate both Amhara and Afar states the same way they did in Tigray, but there was no positive response. After the withdrawal of federal forces from the region T-TPLF has crossed into the neighboring states and committed atrocious crimes.

"What we have observed from the expert commission is that they have made the attempt to invite the UN Security Council intervention to the renewed conflict which has been triggered by the T-TPLF and transgressed their mandate. By the same token, the UN Human Right council doesn't have the mandate to intervene in the peace and security matters which is the domain of the UNSC," Ambassador Zenebe remarked.

Speaking to the *Ethiopian Press Agency (EPA)*, International Relations and Diplomacy Lecturer at Civil Service University Endale Nigussie noted that, the commission cannot save the terrorist faction in this way because its "report" is far from credible.

As to him, the "report" is deliberately looking for mistakes and excuses to maintain the existence of the T-TPLF group and designed to hide the faction's corrupt practices. Because Ethiopians exposed the TPLF as a terrorist to the international community, this means that members of the commissions themselves have been traveling with the terrorist group by providing direction and financial supply. "Therefore, they want to take this burden of their violence and wrongdoing to someone else. Neither Ethiopians nor the international community will ever accept this."

The expert further highlighted that, the commission is not making the "report" public because they do not want to blame the group that took the aid to the well and brought weapons to the fort. According to the "report" they announced, the commission's support to the terrorist group is very immoral. "Using humanity for this obscene act is very disgraceful and the commission's use of human rights for political gain is also shameful."

The fact that three individuals were allowed to write a fiction without coming to the place and leaving behind the report studied by a legal and international organization is far from credible. This approach will not change things as much as they want, but will unite Ethiopians more and it also makes Africans see themselves.

"Ethiopians should be able to understand this wrong agenda of the West, which is part of the mixed war. The body that issued the report is itself an illegal group. The report was issued illegally. Therefore, Ethiopians should not be taken away by false propaganda."

Ethiopian Human Rights Commission (EHRC) has called on all human rights groups to implement the Joint Investigation Team (JIT)'s recommendations towards the allegation of violation of human rights following the occurrence of Northern Ethiopian conflict.

Recognizing the limitations and challenges faced by the International Commission of Human Rights Experts on Ethiopia (ICHREE), EHRC said that the report of ICHREE has hindered its selection of incidents and themes to a handful, as well as faced the complete lack of coverage of serious human rights and humanitarian law violations which could amount to war crimes and crimes against humanity in the Afar state.

EHRC underscored that the JIT report together with EHRC's follow-up report on Afar, Amhara, and parts of Tigray states, remain the most comprehensive reports on violations and abuses of international human rights law, humanitarian law, and refugee law committed following the occurrence of the conflict.

"The Inter-Ministerial Taskforce of the Government of Ethiopia has to reinforce measures towards the timely, effective, and visible implementation of the JIT recommendations while maintaining international and regional standards."

Noting ICHREE to enhance its engagement with the JIT, EHRC pointed out the need for supporting on implementation of the JIT recommendations related to transitional justice and related areas.

Explaining its commitment to play its role, EHRC said that it is ready to cooperate with the ICHREE within the framework of cooperation proposed, including support to the ICHREE on discussions with the State to grant access to affected areas in Northern Ethiopia.

As the report is full of fictitious stories that do not reflect the ongoing circumstances on the ground, the international community should do everything to lambaste the evil deeds of the report and bring into contact the world with the truth. Regardless of the fact that the government has been leaving no stone unturned to extend an olive branch with a focus on getting the disgruntled group into the negotiation table at the earliest possible time, the Commission's report fails to give credit to the gospel truth.

As the fake report released by the commission focuses on belittling the continuous efforts of the government to beat swords into plowshare and perplexing the global community, concerned authorities should go the extra mile to disseminate the universal truth sooner rather than later.

Uganda closes clubs, limits gatherings to curb Ebola spread

Officials at Mubende Hospital in central Uganda install beds meant for the Ebola Treatment Unit on September 22, 2022. Health officials have suspended the operations of entertainment centres and banned crowded burials and wedding parties in Mubende District to curb the spread of Ebola.

Health officials and civic leaders have suspended operations of entertainment centres and limited the number of people attending burials and weddings in Mubende District as they race to curb the spread of the Ebola Virus Disease (EVD).

The country has confirmed seven cases of Ebola so far, including one death - a 24-year-old who was confirmed dead on Tuesday.

On Thursday, Health Ministry spokesperson Emmanuel Ainebyoona said the death of a child in the area has been linked to probable Ebola.



In Mubende, the district Ebola taskforce imposed restrictions on visits to public offices in measures that mirror the standard operating procedures (SOPs) to curb the spread of Covid-19.

Mubende Resident District Commissioner, Ms Rosemary Byabashaija,

who also doubles as the head of the Ebola taskforce in Mubende, said allowing gatherings to continue would be risking people's lives as the virus spreads rapidly through physical contact.

"Since Ebola is spread through body contacts and it can highly be spread in congested places, we have come to a decision to suspend entertainment places, congested places, limit number of people attending weddings and introductions," she

AfCFTA moves to pull women and youth into trade with new protocol

a protocol to ensure participation of more women and youth in trade.

This week, AfCFTA Secretary General Wamkele Mene said the fund, created through the Afreximbank and known as the AfCFTA Adjustment Facility, will be used to cushion countries from short-term revenue losses once they lift tariff barriers for cross-border trade.

Tomorrow, Monday September 26, 2022 is the Bon fire festival (*Demera*) which is also the eve of the *Meskel* Holiday in Ethiopia will be held across all parts of the country.

In literatures, *Meskel*, or cross, is described as a special festival to commemorate the finding of the true cross on which Jesus Christ was crucified. According to the legend, the Byzantine Empress Elleni was lead to the place where the cross was hidden by smoke from a fire which she had been instructed to make in a dream. It has also

a pre-Christian origin, to mark the end of the rainy season. In most places, as in Addis Ababa, the festival is celebrated on the eve.

In Addis Ababa, young men and women, dressed in white with red sashes, form processions and make their way, singing and dancing, to Meskel Square in the centre of town. They are joined by hundreds of priests and deacons from churches around the city, who bring drums and the ornate crosses used in religious ceremonies.

As it gets dark, the *Demera*, or bonfire made up of dried sticks and bedecked with yellow flowers, is lit, commemorating the action taken by Empress Elleni. The direction is which the bonfire falls is said to indicate what will happen to the country in the year to come. Celebrations and street parties continue throughout the town into the night, with each neighborhood having its own *Demera*.

The eve of Gifata festival is called "Bakra Keira" in the culture of Wolaytas.
