## **Small-Scale Farming: Entrepreneur cultivates fish farming in Addis**

Considering the growing demand for fresh fish in the suburb of metropolitan Addis Ababa, Aynalem Mulugeta, a young entrepreneur has taken an initiative to provide a sustainable solution with small-scale fish farming for which he was acknowledged by the Ministry of Agriculture.

Despite the availability of market opportunities, the entrepreneur is struggling with challenges related to shortage oflandand he is not even yet licensed for the pond where he is now fishing.

Applying for a land license on one hand, Aynalem continues making waves in the local community on the other through proving the capacity of urban farming by supplying 10 to 15 kilograms of fresh fish daily from his fishpond located in the

### Council vows to strengthen disaster emergency response activities

**ADDIS ABABA (ENA)-** The Ethiopian Disaster Risk Management Council has set out future directions to intensify the disaster emergency response activities.

In its emergency session held in Dire Dawa City, the council has discussed in detail on the current disasters including the recent landslide and floods triggered by heavy rains and reviewed the humanitarian aid response.

Deputy Prime Minister Temesgen Tiruneh who is also chairpeson of the council recalled that many of the citizens have lost their lives following the sudden accidents caused by heavy rains in this rainy season.

Recall that a landslide which occurred in last July 2024 and triggered by heavy rain in the Gofa Zone alone has killed over 231people.

Acknowledging the current national efforts to mitigate risks are commendable, the Deputy Prime Minister stressed the need for establishing effective emergency preparedness system to manage the future accidents.

Temesgen further emphasized on the importance of revisiting and inspecting the government disaster risk management structures in a way to give a proactive emergency response and handle crises.

Accordingly, the Deputy Prime Minister has given executive order to the council in order to enhance disaster prevention activities and provide timely information, noting there is forecast data that indicates other disasters may still occur.

For this, he said, there is a need to inform the citizens in the areas of risk and relocate them when it becomes necessary.

The Deputy Prime Minister highlighted the importance of enhancing relief support for those displaced by disasters. Temesgen also underlined that it is to focus on finding long-term solutions in this regard.

The rehabilitation activities of citizens who have been displaced by the previous conflicts will continue to be strengthened in coordination with the various regions of the country, he stated.

On the other hand, he stressed that accurate information of beneficiaries and citizens seeking support should be clarified and linked to the national identification program.

He also emphasized on the strengthening of resource mobilization initiatives for emergency response works.

The Ethiopian Meteorological Institute Director General Fetene Teshome on his part mentioned the prediction of the ongoing Ethiopia's rainy season which has continued to receive heavy rains since May 2024 due to the influence of La Niña.

He also indicated that above-normal rainfall is expected to continue until September, adding that citizens in the Abbay, Awash, Baro Akobo, and other basins are at risk of flooding.

Ethiopian Disaster Risk Management Commissioner Shiferaw Teklemaryam has reported that this year's winter has seen unprecedented disasters.

He stated that evacuation of citizens from river basins and slopes vulnerable to floods and landslides has begun, and urged the leadership to reinforce these efforts.

Shiferaw stressed that the society should notice early warnings and take precautions to protect themselves from any future danger.

Finally, the Ethiopian Disaster Risk Management Council has set out direction to consolidate activities of covering humanitarian aid by the country's own capacity.

### Local company EVs assembling on rise

ADDIS ABABA —In an ambition to facilitate knowledge and technology transfer and promoting the national green legacy program, a local company based in Debre Berhan is supplying the market with hundreds of electric vehicles of different types.

Part of the Belayneh Kindie Business Group, the Debre Berhan Phibela Industry Car Assembly PLC is mainly assembling electric vehicles and feeding the local market, Company Director General Mohammed Ahmed said.

Most of the vehicles do not release noise and carbon dioxide that affect the environment so that they go in compliance with the national plan of achieving green legacy and green development, he emphasized.

Inaugurated this Ethiopian fiscal year, the company has been assembling various trucks, city buses and minibuses which are compatible to the country's green legacy initiative, he stated.

He told the Ethiopian Press Agency that his company has assembled over 200 minibuses while assembling city buses in an agreement with the Debre Berhan and Addis Ababa city administrations.

The industry is playing a vital role in advancing technology transfer and job creation in the sector thereby saving the country a significant amount of foreign currency to import such products, he stressed.

"Our factory has immense potential in utilizing the country's abundant electric



generating capacity thereby reducing the expenditure to import fuel," Mohammed said.

He elaborated that the electric city buses assembled by the Phibela Industry can cover some 540km with less than 500 Birr expense for electric energy than the traditional buses that consume fuels at a cost of about 40,000 Birr to cover almost similar distance.

The company promotes technology transfer to Ethiopia and introduce new knowledge in the sphere in the future, he believed.

According to the Director General, Phibela

has a capacity of producing about 12 vehicles per day though it is currently assembling with 40% of its capacity.

It has created some 400 jobs though it would employ a total of 1000 citizens when it gets fully operational, he indicated.

Mohammed also expressed that the industry is working with universities to produce spare parts in the country to curb shortage of inputs and hard currency.

In this process, the company has planned to promote university-industry linkage and nurturing skilled manpower, he added.

### Dashen Bank launches Dube Ale-IFB service

This innovative Buy-Now Pay Later scheme allows customers to purchase goods and services on credit while strictly adhering to Shariah principles.

DubeAle-IFB offers short-term financing through partnerships with merchants and traders, enabling customers to make purchases and repay the amount over three, six, or twelve months without any interest or profit mark-up. According to Dashen Bank CEO Asfaw Alemu, customers can easily access the service by downloading the "Dube Ale-IFB" application from the Play Store, registering, and visiting a nearby Dashen Bank branch for account verification.

After verification, they can make credit purchases from participating physical and online stores. The system includes professional guidance to help customers determine their financing limit based on their income.

To use the service, employed customers need to submit a letter from their employer, confirming their income and employment status. Repayment can be made via Amole,



Dashen Bank's mobile banking platform or through automatic deductions from their bank account. Customers with fixed assets can also provide a third-party guarantee or secure the financing with a bank deposit.

The maximum spending limit for DubeAle-IFB is set at Birr 700,000 with all payments processed exclusively through the application.

This service is anticipated to boost economic activity by allowing consumers to purchase products and services without the need for immediate cash.

Dashen Bank previously launched the popular Amole payment platform and introduced the DubeAle conventional banking service in 2023.

### **Double checking decisions** than lamenting missteps

It is not a hyperbole to claim that no country comes near to Ethiopia regarding the life sacrifice paid to ensure an enduring peace and a reliable stability in Somalia. This virtuous deed consummated with success has not only won fame and recognition to Ethiopia but has also allowed it to standout as the alacritous troubleshooter in the region. To date, Ethiopia displays the stamina to sustain the tempo. Owing to these virtues various countries are willing to work with Ethiopia.

It could not be gainsaid that by seeking ways for armistice and facilitating means for warring factions of divergent political views to resolve their disputes round the table Ethiopia had labored a lot and played a paramount role in Somalia's time of need when Siad Bare's government collapsed and the country failed to stand on its feet as a nation.

Considerate of the security needs of other countries in the region too it has emasculated the terrorist group Al Shabaab posing threat in the region. ## Leapfrogging into the Ethiopian New Year with full confidence for accelerated development

The Ethiopian New Year is characterized by the end of the long rainy season, a bright sky and a dazzling sunlight. The countryside turns into gold with the yellow daisies (adey abeba), which covers the entire fields in rural areas of Ethiopia are in bloom at this time of the year.

The festival is celebrated with the singing of special songs dedicated for this holiday by Girls dressed in traditional clothes and giving the bouquets of flowers (adey abeba), they collected from the fields to each household. In return, they often receive a small gift, usually money. On the eve of the New Year, young men gather in groups singing songs that herald about the New Year. They sing from house to house getting gifts usually in the form of money.

The celebration of the Ethiopian New Year, Enkutatash, meaning the "Gift of Jewels" is believed to be celebrated since the time of the Queen of Sheba. During her visit to King Solomon of Israel in Jerusalem, the Queen had gifted the King with 120 talents of gold (4.5 tons) as well as a large amount of unique spices and jewels, as mentioned in the Bible.

When the Queen returned to Ethiopia her chiefs welcomed her with precious jewels to replenish her treasury. Enkutatash has been celebrated since then.

Lighting bonfire on the eve of the New Year is also part of the celebration. Male members of the family light a bonfire made of branches and leaves of trees to say good bye to the concluding year and wishing for a brighter year, peace and prosperity for the family and the country as a whole.

The Ethiopian calendar is derived from the Alexandrian or Coptic calendar. Like the Julian calendar, it adds a leap day every four years without exception.

The Ethiopian calendar has twelve months of 30 days plus five or six epagomenal days, which comprise a thirteenth month. The sixth epagomenal day is added every four

As the Ethiopian counting of years begins in the year 8 of the Common Era, a calendar era often used as an alternative naming of the AD, there is seven to eight years gap between the Ethiopian and Gregorian calendar. This mainly results from an alternate calculation in determining the date of the Annunciation to Virgin Mary.

The Common Era (AD) follows the calculations of Dionysius, a 6th-century monk, while the non-Chalcedonian countries continued to use the calculations of Annius, a 5th-century monk, which had placed the Annunciation of Christ exactly 8 years later. Because of this, on 11th of September 2016, it will be 2009 in the Ethiopian calendar.

Enkutatash is a very festive occasion and a

get together for families. The rainy season is the busiest time for families in rural areas, as it is the main season in the highland areas for cultivation of crops. The end of rain means time to get some rest and celebrate.

The Ethiopian New Year is a source of inspiration for all Ethiopians. Farmers in the rural areas tend their farms expecting a bumper harvest in the next season for food stuff. School children are getting ready for the new academic year while university students throughout the country are preparing themselves for yet another year in college.

This year Ethiopians celebrate Enkutatash with a mixed feeling of hope and challenges. The country is grappling with higher level of inflation which seriously affects people with less income due to the skyrocketing of prices on foodstuff. Moreover, the devastating effects of two years of war in the northern part of the country and now another round of war in Amhara has displaced millions of people who would require enormous amount of food aid. Sporadic conflicts across several regions have affected normal duties of farmers some of whom are in short of agricultural inputs.

However, everything is not bleak for Ethiopia, the country is now enjoying good rainy season and there is a relative stability in most of the areas in the country. Ethiopia conducted a promising level of diplomatic activities in terms of climate, diplomacy and successfully conducted the first part of the second phase of National Green Legacy Initiative by planting more than 30 billion trees to date since 2019. After painstaking and rigorous negotiations, the nation was able to secure more than 27 billion USD in foreign loan and grants which set the cornerstone for the implementation of Ethiopia's Macroeconomic Policy.

Rehabilitation of the war devastated areas in northern Ethiopia is going on along with attempts being made to distribute relief food to the needy. Despite huge economic challenges, the country has been able to register economic growth exceeding 7%.

Ethiopia has now ceased to import wheat and is also looking forward to be selfsufficient in rice and other food items through the Basket Bounty Program.. The country expects more FDI for the years 2017 propelling more progress in better performance at Ten Years Perspective Plan and Digital Ethiopia by 2025.

Accordingly, more focus is to be made on improving the entire education system in the country through the participation of major stakeholders and the public at large.

Traditionally Enkutatash is an annual celebration of peace and tranquility among all the people of Ethiopia and is also a season of optimism and hope for better life.

"My fishpond area is about 2000 meter square and 200 meter faraway from Legedadi River that streams from the city surroundings. I always use electricpowered pump to fetch water from the river. I was once awarded by Ministry of Agriculture for my achievement," he told The Ethiopian Herald.

Aynalem's venture is not only providing fresh fish but also contributing exemplary experience to the local economy. His business is becoming an alternative to the limited fish supplies to his customers who were buying and transporting fish from distant regions.

"I began with pond fishing with a vision of creating sustainable income and actually become source of fresh fish within the vicinity of the city. I need the government to support me with land provision. I am not licensed for the ownership of the pond where I am fishing. I could supply more amount as the potential is still untouched," he underlined.

Seconding to Aynalem's sentiment, Investor GirmaMengistu, who involved in animal feed production with his enterprise named Friendship Agro-Industry PLC, said that the agricultural sector holds more opportunities far bigger than the existing

"We are producing and supplying animal

feedings. Almost 98% of our products are made of locally produced inputs. We just need the support of the government to expand our businesses that could benefit more people and create jobs," he said.

The future looks promising for agricultural entrepreneurs as the government pledges support to expand agricultural funding. The government is supporting investors through land provision and incentives. Besides, it has expanding platform for the use of improved farming tools, soil fertilizers, and seeds, Agriculture Minister, Girma Amentie (PhD) said while opening the Agricultural investment exhibition.

highlighted innovation and mechanization as key priorities in advancing the agriculture sector.

The agriculture sector, which contributes one-third of national GDP and accounts for 65% of employment, is growing at an average rate of 5.2% per annum in recent years, according to Plan and Development Minister, Fitsum Assefa.

Legal and structural reforms are also expected to attract more private sector investment, including foreign companies. Financing had been a challenge for the sector, with foreign investment was rare. ### No room for alien forces to interfere in Ethiopia, Somalil and seaport access deal

Since the dawn of history, Egypt has been interfering in the internal affairs of Ethiopia at various points in time. As there is nothing which makes Egypt happier than driving Ethiopia into unfamiliar waters and delving into unexplored realms, the county has been working around the clock to drag through the mire the reputation of Ethiopia and the positive moves unfolding in various regions of the country.

It is important to highlight that since the laying of the cornerstone for the construction of the Grand Ethiopian Renaissance Dam (GERD), Egypt has been working around the clock to interference in the internal affairs of the country and expressing its disappointment in various ways in the face of Ethiopia's stance on fair and equitable water use on Nile River.

In the present circumstance, failing to learn from its past mistake, Egypt has sustained expressing its disappointment on the heels of the singing of the Memorandum of Understanding (MoU) between Ethiopia and Somaliland on the topic of access to seaport.

In actual fact, Ethiopia with a population of more than 120 million has no access to seaport which enables the country to smooth the path of its import and export procedures, grow its economy and other related aspects. To everyone's dismay, aside from fanning the flames of hatred and animosity between Ethiopia and Somaliland, Egypt has continued badmouthing the recently signed deal.

Somaliland vowed to continue defying and counter-fighting the ongoing smear campaign by what it calls 'arch and historical adversaries' to fracture the glowing ties between Addis Ababa and Hargeisa.

The all-weather Comradery between the two neighbors will get more boosts devoid of external meddling, said recently the Somaliland Ministry of Information in an exclusive interview with *The Ethiopian Herald*.

Since the signing of the Ethiopia –Somaliland sea deal, some external entities tried to besmirch the very intent of the agreement and bewilder the international community with coordinated propaganda, Director General at the Ministry Mustafe said "Some Arabian entities that have issues with Ethiopia on the Nile are trying to use us as a weapon to attack our brothers in need. But surely, Somaliland cannot serve as a bullet to hit Ethiopia,"

"We believe Ethiopia is the second country for Somalilanders. Ethiopia was there by our side when we were being subjugated and chased by a dictatorial rule.

Sharing the above rationale, Ethiopian Ambassador to South Sudan Nebil Mahdi also underlined Ethiopia's access to sea demand is unavoidable. "The population of Ethiopia is surging and will hit 150 million in the near future. So, it is clear that having access to the sea will no longer be avoidable."

"Ethiopians have a long history of repelling external pressures. "There must be no difference on national issues. We need to learn from countries that are defending their common interests while they are in political and internal disputes."

There may be polarized political views among people and political parties. However, Ethiopians need to unite themselves to make their national interest true. If not, the country could not ensure the development it aspires for long.

Ethiopia's desire is taking the country to a new height; it has continued working in close collaboration with its neighbors in various aspects of development activities is to grow together without causing any harm to any downstream nations.

No matter what naysayers say, Ethiopia and Somaliland will not abstain from attaining the intended target down the road and taking the Horn region to new heights in the shortest possible time.

### Aptly injecting foreign currency into the intended targe

It is well recognized that traders, economists, and analysts await trade announcements because the balance of trade is seen as an indicator of Gross Domestic Product (GDP) of a given nation, country's economic well-being, and its potential for growth. Obviously, currencies and equities can fluctuate when trade statistics are released, presenting trading opportunities. National Bank of Ethiopia has intervened in foreign exchange markets in order to achieve a variety of overall economic objectives such as controlling inflation, maintaining competitiveness or maintaining financial stability.

Keeping this in mind, *The Ethiopia Herald* had a short stay with Getinet Abera, an economist graduated from Addis Ababa University to have a piece of information about the utilization of foreign exchange pumped to the economy.

He said, "Currency floating switches demand from imports to domestically produced goods by increasing the relative prices of imports and export industries. As the step helps the nation become more competitive in international markets by stimulating domestic production of traded goods and inducing domestic industries to use more domestic inputs, the measure the Ethiopian government has taken is legitimate and acceptable amid some challenges."

As to him, of course, an exchange rate is the price of one currency expressed in terms of another currency or group of currencies. For developing economies such as Ethiopia that actively engage in international trade, the exchange rate is an important economic variable. Movements in the exchange rate influence the decisions of individuals, businesses and the government as well. Collectively, this affects economic activity, inflation and the balance of payments. There are different ways in which exchange rates are measured. Over the years, there have been also different operational arrangements for determining Ethiopia's exchange rate. The Ethiopian dollar is now freely traded in foreign exchange markets."

According to Getinet, in the long-run, Ethiopia needs to maintain its international competiveness for which nominal exchange rate adjustment will be an important instrument. The precise objectives of policy and how they are reflected in foreign exchange market intervention depend on a number of factors, including the stage of a country's development, the degree of financial market development and integration, and Ethiopia's overall vulnerability to a range of alarms.

He further stated that the balance of trade influences currency exchange rates through its effect on foreign exchange supply and demand. On the side of the government, three immediate objectives of intervention have been important: to influence the level of the exchange rate; to dampen exchange rate volatility or supply liquidity to foreign exchange markets; and to influence the



s to him, of course, an exchange rate is the price of one currency expressed in terms of another currency or group of currencies. For developing economies such as Ethiopia that actively engage in international trade, the exchange rate is an important economic variable

amount of foreign reserves.

According to Getinet, it is found that expected floating of the domestic currency, while relatively high, does not play a major role in sustaining the dollarization of transactions. Conversely, preferences for the use of foreign money are strongly influenced by people's perception that foreign money is already widely used in the economy. What matters here is aptly injecting foreign currency into the intended target helps the nation making a difference in terms of socioeconomic progress.

He said, "Obviously, currency is a medium of exchange for goods and services. In short, it is money, in the form of paper and coins, usually issued by a government and generally accepted at its face value as a method of payment. It is the primary medium of exchange in the modern world, having long ago replaced bartering as a means of trading goods and services. In the 21st century, a new form of currency has entered the vocabulary and realm of exchange. Currency is simply one, tangible form of money."

Many countries in the African continent have been affected by a slowdown/ downtrend, in their already very low levels of economic and social development, as a consequence of both internal and external factors. These factors are, among others, the foreign debt burden, the insufficient achievements in financial resource mobilization, price and exchange rates distortions, the high dependency on exports of few commodities, and unfavorable weather and internal security conditions. In order to interpret the causal links underlying this negative performance in the Ethiopian case, a time-series analysis has been carried out on various indicators of the real and monetary economy, Getinet said.

He further stated that foreign exchange market intervention is driven by broad macroeconomic objectives so as to control inflation or maintain internal balance, to maintain external balance and prevent resource misallocation or preserve competitiveness and boost growth as well as to prevent or deal with disorderly markets or predicament. To achieve these objectives, the National Bank of Ethiopia might seek to target the level of the exchange rate, dampen exchange rate volatility or influence the amount of foreign reserves.

The economic objectives of intervention will influence its targets, for instance the under a floating exchange rate regime, if the concern is with inflation, the estimated pass-through from exchange rate changes to inflation is relevant, and the behavior of the nominal exchange rate will be monitored with a view to preventing sharp changes or volatility.

If external balance is the primary concern, the real exchange rate and the current account, and factors that may influence these variables, such as the terms of trade or capital flows, will be monitored. If the concern is with financial stability and crisis prevention, then market conditions can be highly informative incorporating concepts like how fast the exchange rate changes; the size of exchange rate volatility; transaction volumes; and the exposure of different market participants, he opined.

The purpose of National Bank intervention is to influence the exchange rate as excluding national bank operations that are not intended to influence the exchange rate can rule out a number of transactions that might have no underlying stabilization policy goal, such as small technical transactions, foreign reserve purchases financed by foreign currency borrowing, or transactions that are similar to those of other economic agents and are related to underlying economic activities, for instance using foreign reserves to purchase

a piece of equipment on behalf of the government.

In some cases, national bank does not consider as intervention transactions that are mainly intended to regulate the amount of foreign reserves, particularly if they are automatic or based on rules, rather than discretionary, he added.

He said even when the exchange rate is floating, national bank sometimes prefers to intervene in the foreign exchange market rather than conduct an open market operation to achieve a monetary policy objective. Understanding the motives for and characteristics of national bank operations in the foreign exchange market under these conditions is of considerable policy interest, whether the operation is labeled intervention or not

Besides, national bank foreign exchange transactions can affect the exchange rate even if this is not the primary intention. For example, in pursuing its policy of reserve accumulation, the National Bank of Ethiopia has been trying to limit the impact on the exchange rate by entering the market only when large supplies of foreign currency become available.

However, the transactions are large, so it is likely that the impact on the exchange rate is significant, even if this is not the primary purpose. Reserve accumulation can also affect the exchange rate because of its impact on sovereign ratings and spreads. True, the national bank finds some positive impact of reserve accumulation on sovereign credit ratings. A traditional reason for such intervention is that the government wishes to control the allocation of foreign reserves. Another reason is to insulate the foreign exchange market from the impact of very large foreign exchange flows that is to dampen exchange rate volatility.

He further said that the forex market refers to the decentralized market for the trading of currencies which determines specific foreign exchange rate for every currency. Here, sorting out the pros and cons of joining the forex market with reference to the foreign exchange management regulations and foreign exchange management plays a very crucial role in currency trading in the global forex market as it controls and manages all the exchanges in every currency.

In sum, exchange rate intervention remains popular among many emerging market, small/ medium and open advanced economies. The relative values of currencies are influenced by the demand for them, and that demand is influenced by trade. If Ethiopia for instance exports more than it imports, which is known as a trade surplus, there is a high demand for its goods, and thus, for its currency. The economics of supply and demand dictate that when demand is high, prices rise and the currency appreciates in value. In contrast, if the country imports more than it exports, which is known as a trade deficit, there is relatively less demand for its currency, so prices should decline. In the case of currency, it depreciates or loses value.

## Government, stakeholders encourage private sector role in renewable energy transition

Our planet is undergoing a silent crisis. This crisis is neither a war nor a pandemic, but a slow, insidious change that threatens to unravel the very fabric of our existence. The country's renewable energy policy is primarily guided by its Climate Resilient Green Economy (CRGE) strategy, which outlines Ethiopia's goal of becoming a carbonneutral middle-income country through the expansion of renewable energy, reforestation, and other sustainability initiatives.

It needs to meet rapidly growing electricity demand, reduce greenhouse gas emissions, and build climate resilience. The country has abundant renewable energy resources, including significant hydropower, geothermal, wind, and solar potential. Developing these resources is seen as key to supporting Ethiopia's economic and social development goals.

To achieve this, the government has invested heavily in expanding its installed capacity for the renewable energy transition. Several largescale renewable energy projects are currently underway or in the planning stages across the country.

EIC Commissioner Hana Arayaselassie said that the government has been revising policies and legal frameworks in a bid to promote private sector engagement in the renewable energy sector, but it has not yielded fruit because of a lack of streamlined institutions and collaborative interventions among stakeholders, institutions, and the private sector

She has also asserted that the country has immense potential in renewable energy sources such as hydro, wind, geothermal, and solar



power, in spite of the minimum investment in the sector. To address this gap, the commission is working on investment promotion through providing incentives to investors.

The commission is promoting investments by offering incentives to investors in an effort to close this disparity. Even though Ethiopia is one of the leading nations in the green economy and has a virgin market, only roughly 55% of people have access to electricity.

For his part, MoWE Senior Energy Advisor Gosaye Mengistic stated that Ethiopia is one of the few countries in the world generating almost all its electricity from renewable sources, mostly hydropower and green energy.

However, he emphasized that the generation capacity and related infrastructure development are very low, since the country's electricity access rate is not more than 54% and the clean cooking access is about 10%.

Gosaye underscored that with six years of ongoing effort, the overall electricity access rate has increased from 44% to 54%, but still 46% of the population lacks access to electricity.

Although there has been progress in electrification in recent years, the expansion rate is still far from what is needed to achieve universal electricity access by 2030. The work is constrained by limited funding, weak implementation capacity, and a lack of imported materials, he said.

Hana emphasized the need to adjust generation and transmission opportunities accordingly in order to satisfy the remaining rate concurrently with the established industrialization aim in the manufacturing and other sectors.

As to her, prospective investors have expressed a strong desire to involve in the renewable energy industry by creating a playground through improved banking and investment ecosystems.

She further stated that the commission and UNCTAD had started a three-year operational project to showcase the nation's potential as a hub for renewable energy and attract foreign investment.

The government, understanding the threat posed by climate change, has embarked on a bold transition to a renewable energy policy. This visionary shift, a beacon of hope in a world struggling to adapt, signifies a commitment to a sustainable future, not just for Ethiopia, but for the entire planet. By harnessing the power of nature, Ethiopia is leading the way, demonstrating that a greener future is not only possible, but essential for our collective survival.

Furthermore, Ethiopia's renewable energy policy represents an important component of the country's broader sustainability agenda and efforts to transition to a low-carbon, climate-resilient economy. This energy transition also promises significant economic benefits, creating new industries, generating jobs, and attracting foreign investment. Furthermore, it ensures energy security for a nation that has historically faced power shortages.

The flood inundated their Den and its volume continued snowballing. Sacredly the young mouse looked at the water from the safety of her mother's shoulder.


The "Mew, mew, mew..." sound dinning into their ears continued near their hole. The rodents' dread increased. The size of the swamp became shoulder high.

## Constitutionalism is at the heart of the Pretoria peace deal

Since the signing of the Pretoria peace deal, things have been significantly improving in Tigray state with better humanitarian and basic services. With the guns silenced, the Tigray interim government was established, and the agreement has been implemented accordingly. The Ethiopian government has been doing its level best to walk the talks and engage in peaceful settlement of issues. The ruling Prosperity Party and Tigray People's Liberation Front have been holding negotiations to find a political resolution and smooth the way forward. The government has also been making extensive efforts.

Following the inking of the peace deal, the Ethiopian Government and Tigray interim administration have been doing their part and have taken decisive action to carry out the provisions of the agreement as stated in the agreement. As a result, the peace agreement has been fully implemented, and the agreements made by the two sides have been gradually put into practice.

Resuming essential services, facilitating unimpeded access to humanitarian aid, reestablishing law and order, and bringing the State back to normalcy were all made possible. The Government Communication Service (GCS) stated that the fundamental principle of the Pretoria Agreement is adherence to the Constitution and its institutions.

Communities who were displaced from their area are returning to their villages and there have been attempts to implement transitional justice and demobilize and reintegrate fighters. In spite of the progress, there has been some reluctance and illegal activities displayed by TPLF.

Recently, the Government Communication Service (GCS) issued a statement asserting that the central principle of the Pretoria Agreement is adherent to the constitution and constitutional institutions. According to the statement, in all respects, the Pretoria Peace Agreement revolves around adherence to the country's constitution and respecting its institutions.

In a statement it issued today on current affairs of the country, GCS recalled that the National Election Board of Ethiopia (NEBE) has recently issued a registration certificate to TPLF as a political party in accordance with the amended election proclamations number 1332/2016 article 2 (1).

It said the government accepts and commends decisions made by constitutional institutions based on legal and institutional freedom as the fruit of the ongoing reform.

The TPLF lost its legal status following the decision made by NEBE based on the Proclamation of Political Parties' Registration and Code of Conduct. The Board passed this decision due to TPLF's involvement in violent activities.



The GCS emphasized that this decision was independent of the subsequent declaration of the TPLF as a terrorist organization by the House of People's Representatives.

Regarding the Pretoria Agreement, the statement clarified that the federal government's obligation was to facilitate the removal of the TPLF's terrorist designation, as indicated under article 7 (2) (C) and there is no particular responsibility or obligation that the government had taken concerning TPLF's legal status or registration.

The statement further asserted TPLF's commitment to respect the constitution, laws, federal institutions, and other constitutional institutions as outlined in the agreement's article 7 (1) stressing the need for TPLF to operate by complying with the country's political party registration laws and NEBE's mandate.

Hence, the issue of TPLF's legal status should be resolved only through the existing pertinent laws and the procedures of NEBE with respect to the Pretoria agreement.

The statement noted that the federal government has been making efforts to facilitate ways for the party to regain its status as a political party by conducting a series of discussions with the leaders of TPLF and NEBE.

According to NEBE's position in this matter, the only legal alternative available to TPLF is to register as a new party using the same procedures that other newly formed political parties must follow.

However, TPLF argued for recognition as an existing political organization insisting that it is an old political organization. It also claimed that the matter is not only legal but political and requires a particular political decision.

Accordingly, to bridge this gap and ensure a

peaceful resolution, the government initiated legal reforms to accommodate the TPLF and other similar groups by recognizing the freedom and independence of institutions.

Following these legal amendments, the federal government amended the law and was approved by the House of Peoples' Representatives.

After revising the Election, Political Parties Registration, and Code of Conduct Proclamation, the Ministry of Justice communicated the necessary steps for the

TPLF to obtain legal status to the NEBE.

The government emphasized its proactive role in facilitating discussions between the NEBE and the TPLF. Therefore, the statement underlined that the government has done everything to resolve the issue of TPLF's legal status.

The election board has requested cooperation from the board in order to register TPLF and gain its legal status and recognition based on the amended law, the Government Communication Service indicated.

Accordingly, TPLF has been registered and granted its legal status as a political party based on the amended proclamation after it submitted its program, bylaw, and other related documents to the National Election Board of Ethiopia.

GCS concluded its statement by calling for cooperation among all stakeholders to prioritize peace, reconstruction, and development. It urged a shift in focus from contentious debates to constructive efforts that benefit the people.

The GCS in its statement also called for cooperation and to prioritize peace, reconstruction, and development and for a shift from contentious debates to constructive efforts that benefit the people.

True, unproductive debates and being extremely stubborn benefit no one as it yields any good. We also fully understood the undesirable consequences of dissension and discord.

The government has shown its firm stance on peace by implementing the terms of the Pretoria Agreement accordingly, even though some aspects need to be fast-tracked by both parties. Thus, putting aside the narration that gets no one anywhere, all parties have to work in the best interests of the people at all times.
