## Ethiopia, Malaysia forge stronger ties

• Eye expanded trade, investment

**ADDIS ABABA** – Ethiopia and Malaysia have reaffirmed their commitment to strengthening diplomatic relations that have flourished for over half a century, according to Prime Minister Abiy Ahmed (PhD).

During an official working visit to Kuala Lumpur, Prime Minister Abiy held discussions with Malaysian Prime Minister Anwar Ibrahim, where the two leaders agreed to deepen bilateral ties.

In a media statement, Prime Minister Abiy emphasized the significance of the over 50-year relationship between the two nations. Both leaders underscored the importance of high-level visits and dialogue in elevating cooperation across key areas.

In a message to Malaysian businesses, Abiy encouraged them to explore Ethiopia's fast-growing economy, which offers promising opportunities for international collaboration. The two countries identified several strategic sectors for enhanced cooperation, including trade, agriculture, mining, manufacturing, and renewable energy, aligning with Ethiopia's long-term development ambitions.

# Envoys applaud Addis' corridor project for image transformation



### Addis ramps up housing efforts with **public-private investments**

• Noah Real Estate delivers 750 units

ADDIS ABABA - The government is intensifying efforts to address Addis Ababa's housing shortage by introducing legal frameworks that promote both public and private investments, Deputy Mayor Jantirar Abay announced during the launch of new residential units by Noah Real Estate.

Jantirar emphasized that the reforms, including recent macroeconomic adjustments, are part of a broader strategy to foster holistic development. Addis Ababa, now open to joint ventures, aims to improve resource utilization, accelerate structural transformation, and tackle development

"As the third international diplomatic hub and seat of the African Union, Addis Ababa needs rapid growth to meet its governance, employment, and infrastructure demands," the Deputy Mayor said.



government efforts, demand for housing has outpaced results. To bridge the gap, the city is creating a favorable environment for private companies and public-private ventures to expand housing projects.

He acknowledged that despite continuous Among the key players is Noah Real Estate,

which has constructed approximately 10,000 homes over the past decade. On Saturday, the company handed over more than 750 residential apartments with two- and three-bedroom units, along with 32 villas and 45 commercial shops. The properties feature amenities such as a swimming pool, groundwater systems, and sports facilities.

Noah Real Estate's Founder and CEO, Theodros Zerihun, shared that the company recently delivered 900 additional units and plans to launch construction of over 5,000 new homes next month. "In the last decade, we've delivered over 9,800 homes and commercial spaces to more than 25,000 buyers," Theodros said, reaffirming the company's commitment to meeting Addis Ababa's growing housing demands.

The Deputy Mayor praised Noah Real Estate's efforts, noting that the newly inaugurated apartments and commercial buildings meet the city's standards and mark a significant step toward alleviating the capital's housing challenges.

### **New irrigation** projects set to boost commercial agriculture

**BISHOFTU-** Irrigation projects currently under construction will play a critical role in advancing commercial agriculture, according to Irrigation and Lowland Minister Abraham Belay (PhD).

The Minister, who leads the steering committee for the Productivity Enhancement Support for Integrated Agro-Industrial Parks and Youth Employment (PESAPYE) project, stated that the government is working closely with financial institutions to expand irrigation infrastructure.

Three major irrigation sites-Taba, Belechit, and Gidabo-have been evaluated by the committee, and Abraham emphasized the need for seamless coordination to complete the projects on time. The projects will primarily benefit youth in the Amhara, Oromia, and Sidama states, offering them employment opportunities, though the impact is expected to extend far beyond job creation.

"These projects will shift agricultural activities toward a more commercial focus," said Abraham. He also highlighted that businesses have already begun engaging at the early stages of development, ensuring continuity from groundwork to full operation.

The growing agro-processing sector, which depends on reliable agricultural outputs, will also benefit from these irrigation "Strengthening initiatives. agriculture through sustainable irrigation solutions is essential to meeting the demand of Ethiopia's expanding agro-industrial parks," the Minister remarked.

Agriculture Minister committee member Girma Amentie (PhD) praised irrigation efforts and called for increased financial resources to accelerate completion. "These projects are not just about irrigation; they represent a critical step toward achieving commercial agricultural transformation," Girma emphasized, underscoring the importance of timely delivery.

The MoA hosted an event under the theme "Investing in Animal Welfare for Human Wellbeing and Economic Prosperity", with the global tagline "The World is Their Home Too." The event brought together government and non-governmental stakeholders to address the role of animal welfare in public health, food security, and economic progress.

Wubshet Zewdie (DVM), Animal Health Lead Executive Officer at the MoA, emphasized that animal welfare is not merely about kindness but is fundamental to creating sustainable communities. "Animals play a pivotal role in our society and economy, directly impacting food security, public health, and economic development," Wubshet noted.

He highlighted that Ethiopia's ongoing efforts align with the Yelemat Tirufat initiative, focusing on increasing livestock production, reducing imports, and boosting exports. "Livestock health is critical to transforming our economy, ensuring food systems, and preventing the spread of zoonotic diseases," Wubshet added.

### **Reconciling civic nationalism and** ethnocentrism needs due commitment

In Ethiopia, the contradiction between civic nationalism and ethnocentrism reflects the broader challenge of reconciling a deeply diverse society with the need for a unified state. While civic nationalism aims to create an inclusive, stable political environment, ethnocentrism threatens this by fostering division and competition among ethnic groups. Finding a balance between these two approaches remains a critical issue for Ethiopia's long-term stability and development.

the contradictions Notwithstanding between territorial ethnic federalism and civic nationalism, there is also a complex difference between factions in the same armed groups and political entities. It would be enough to mention the differences and rivalry in TPLF the OLF.

A complex combination of personal interest to grab power and lack of solid strategy among the armed groups in Amhara region and Oromia explain why these groups are having it difficult to engage in a peaceful dialogue with the government.

Those Ethiopians in the diaspora who never get into war but trigger ethnic conflicts and finance them never care about the plight of children and their mothers who suffer from their actions but fabricate misinformation that is far from the reality on the ground.

As long as the demands of various ethnic groups for socio-economic development is answered as long as they are represented in the political order in the country, there should not be any contradiction between civil nationalism and ethnic self-assertion. The fundamental question is what is the interest of the people of Ethiopia and how do they hope to fulfill these needs and interests? There is far greater difference between elitist political conspiracy to gain power by the gun and the genuine desire of the people of Ethiopia which the government needs to address.

We are in a situation in which ethnocentric armed groups are looting public property and abducting innocent citizens in demand for ransom, a barbaric action which has nothing to do with liberation, democracy and self-determination. The wars in Amhara and Oromia regions in the name of "struggle for survival and inclusion in government structure without vote is now serving as an inlet for foreign powers to meddle in the affairs of the country.

Commercializing on the agony of the people of Ethiopia cannot go on unabated because citizens have every natural right to live in peace and stability. Ethiopia has more than 100 political parties who have so far done nothing for the people of Ethiopia except complaining and coming up with emotionally charged and unworkable press releases. Some so called politicians and political groupings are already busy trying to fish in troubled waters.

Apart from Ethiopia, ethnocentrism is already taking roots and spreading its tentacles across Africa serving as a tool for triggering conflicts among African countries. This has created a breeding ground for the resurgence of terrorist groups, seas pirates and arms dealers and traffickers. Ethiopia is already busy singlehandedly fighting these forces in Somalia. This seems to create a favorable condition for armed groups who try to destabilize the country from within.

Emotionally charged hatred, languages, wrong profiling of the leadership of the country will never add up to resolving the challenges that this country is facing. National dialogue is he only viable alternative to finding solutions for the outstanding challenges of the country.

Is it possible to reconcile civil nationalism and ethnocentrism in Ethiopia? The writer of this article believes that it is possible but how?

Reconciling civic nationalism and ethnocentrism in Ethiopia requires a strategic balance between promoting national unities while respecting ethnic diversity. Here are several approaches to help achieve that balance:

As stated above, civic nationalism focuses on the idea of a shared national identity that transcends ethnic divisions. To reconcile this with ethnocentrism, Ethiopia can promote cultural diversity within the framework of a unified state. This means encouraging an inclusive narrative that values the contribution of each ethnic group while fostering a sense of belonging to the Ethiopian nation as a whole. National symbols, holidays, and public messaging can emphasize unity in diversity.

Ethiopia's ethnic federalism system, which grants power to ethnically defined regions, often fosters ethnocentric tendencies. Reforming this system to maintain basic human rights without emphasizing ethnicity would help. Moving towards a model where regional governance is based on geographic, economic, or administrative considerations, rather than ethnic lines, could reduce ethnic tensions while maintaining self-governance.

Ethnocentrism often stems from perceptions of unequal access to resources. Ensuring fair distribution of resources, development projects, and opportunities across regions and ethnic groups can help mitigate feelings of exclusion or marginalization. Government policies should prioritize development that benefits all regions, particularly those that have historically been underserved.

Democratic institutions can act as neutral mediators between ethnic groups, ensuring that political representation is based on citizenship and democratic principles rather than ethnic loyalty.

### Green Gursha: ....

Despite these global difficulties, Ethiopia has made significant strides in combating malnutrition. The government, in collaboration with development partners, is expanding access to nutrition for mothers, children, and pregnant women. A new food system document was introduced to address nutrition challenges, though malnutrition remains prevalent.

Knorr's latest campaign, themed #GreenGursha, promotes incorporating greens into Ethiopian meals through the cultural tradition of Gursha-sharing food by hand. This initiative celebrates Ethiopian culinary heritage and emphasizes the importance of healthy eating.

According to Almetsehay Zergawi, Head of the Ministry of Health's Food and Nutrition Office, Ethiopia faces significant nutritional challenges despite its agricultural potential. "Thirty-nine percent of children under five experience stunting due to chronic undernutrition," she reported. In response, the government has introduced food-based dietary guidelines and a new food system strategy involving 15 public institutions to address the issue.

Almetsehay stressed the importance of agriculture in improving nutrition and described food as medicine. "The Ministry of Agriculture is committed to working closely with partners like Unilever to promote healthier eating habits," she said. Almetsehay also emphasized behavioral change as key to overcoming malnutrition, encouraging meals containing at least four food groups per serving and six food groups daily as recommended by the GreenGursha campaign.

Nutritionist and consultant Abenet Tekele cited a study from the Ethiopian Public Health Institute, which revealed that 75%

of children under two have no access to fruits and vegetables. He also pointed to research showing that over 60% of people's emotions are directly linked to their diet. Deficiencies in essential vitamins, such as Vitamin D, affect 95% of the population, leading to issues like depression, fatigue, and dizziness.

Abenet highlighted the importance of foods rich in folate, magnesium, and vitamins D, B, and C to maintain physical and mental health. He urged greater attention to pregnant women, noting that folate deficiency affects 50% of women, which can lead to serious birth complications. Ensuring access to vegetables and fruits could significantly improve maternal and child health outcomes, he added.

Kidist Woldesenbet, Head of the Ministry of Health's Nutrition Desk, reaffirmed the government's commitment to implementing the National Food and Nutrition Policy. Supported by a 10-year strategic plan, the policy aims to foster a healthy, productive society. Partnerships with the private sector, including Unilever, are pivotal to the campaign's success.

Unilever Africa Nutrition Platform Director Selamerchristos Belay expressed excitement about the campaign's positive reception. "This initiative showcases our commitment to promoting green vegetables in Ethiopian cuisine and celebrating the richness of Ethiopian culinary traditions," he said.

Knorr enlisted popular comedian and TV personality Eshetu Melese to further promote the campaign. His humorous approach resonated with audiences, inspiring them to embrace greens as part of their daily meals. "Gursha with Greens" became a memorable slogan of the event, encouraging people to see vegetables as both delicious and essential to their diets.

# Access to seaport pact: Panacea to hurdles, regional integration's linchpin

It is certain that the Memorandum of Understanding signed on January 1, 2024, between Ethiopia and Somaliland plays a paramount role in accelerating seaport access and oiling the wheels of import-export businesses as soon as practicable.

No matter what doomsayers enunciate on the topic of the seaport access deal with a focus on tarnishing the positive images of the deal, Ethiopia has sustained moving forward in the right direction, turning a blind eye and deaf ear to their usual figment of the imagination.

Notwithstanding the fact that naysayers deliberately proceed, giving the cold shoulder to the existing concrete realities, the wider international community has jumpstarted standing by the side of Ethiopia's unvarnished truth.

In actual fact, the agreement, which is in compliance with peaceful resolution, is expected to assist the country in generating employment opportunities and other socioeconomic circumstances.

In the same manner, access to ports will have an abundance of importance in gearing up accelerated economic growth, which in turn makes certain harmony among the people.

In fact, apart from laying the groundwork for accomplishing the country's aspiration to assure access to seaports and branch out its stepping stone to seaports, the pact is considered a linchpin of cooperation and collaborative enhancement.

Speaking to ENA, Professor Joseph Yav who is also Pan African Lawyers Union (PALU) Life time member & Commercial Law Committee Co-Chair recently said, Ethiopia's ongoing quest for having access to seaport is acceptable.

Given its geographical, historical, economic backgrounds, Ethiopia has initiated discussions to secure sea outlet based on the principle of mutual benefits and partnership that provide amicable opportunities to strengthen shared development. Quest for coastal access to sea outlets is essentially considered as a legitimate right to Ethiopia with its sizable economy and population as well as the ever growing import-export trade.

Moreover, the country's direct coastal access is anticipated to increase physical economic growth of the people in the Horn of Africa (HoA), it was learned. For professor Yav, the ongoing Ethiopia's endeavor to secure seaport is extremely important to expedite regional economic growth and collaboration with neighboring countries.

According to him, there are pathways to achieve this goal through peaceful negotiations and international legal frameworks. "Ethiopia deserves access to the seaport like any other nation," Yav noted, urging for discussions that respect



international law and promote shared resources.

Noting that unlocking maritime opportunities lies in cooperation with neighboring nations, the law professor noted that advocating for agreements facilitate access to coastal waters. There is no doubt that the agreement will meaningfully play a part in developing cooperatively with other nations in the Horn of Africa.

It is an undisputable fact that access for additional ports for Ethiopia is fundamental with the intention of properly accommodating its progressively developing economy and population. If truth be told, there is no time like the present for the worldwide community to support Ethiopia's yearn for possessing access to seaport.

It is common knowledge that Ethiopia has been encountering economic and security challenges for dozens of years on account of absence of access to seaport.

If truth be told, it is now high time for Ethiopia to rummage around for additional ports for oiling the wheels of import-export businesses. In view of the foregoing, the country has been on the lookout for alternative approaches to access sea with understandable procedures. In a related move, the seaport access deal is crucial to ensure peace and stability in the length and breadth of the country.

Speaking to the Ethiopian Press Agency (EPA), a Political Science Scholar, Prof. Biruk Hailu in the recent past stated that Ethiopia's acquisition of a sea gate in the strategic, yet volatile region is of great significance to the area's maritime security and repulsing criminal activities.

As to him, the security of the Red Sea and the Gulf of Aden will be more guaranteed if Ethiopia has direct access to a seaport and can participate well in maritime issues. Besides, the seaport plays a critical role in intensifying its commercial activities and deploying the naval forces. Therefore, Ethiopia's aspiration to direct access to port is justifiable and reasonable on legal, moral

and other grounds.

Taking its large population and economic prowess into account, Ethiopia has been suffering a lot in the past 30 and plus years due to the absences of direct access to seaport and the loss has also had a lasting impact on its security and the public wellbeing.

Ethiopia's acquisition of a seaport from Somaliland comes based on two sides' interests and a win-win approach, not by any pressure or coercion. Some interest groups' opposition to the port deal is influenced by the distorted information of our historical enemies.

As a matter of fact, the treaty signed between Ethiopia and Somaliland fixes attention on mutual benefits. It is no hyperbole to say to the deal for sure will smooth the path of the growth of the Horn of Africa and beyond in the shortest possible time and make the future of the region rosy.

Although some groups have continued sparing no effort to sow the seeds of hatred among the people of the Horn of Africa utilizing their usual bogus news stories and perplexing the region, all their endeavors have been missing the intended target and the deliberate objective.

In consideration of the foregoing, Ethiopia in black and white has made an effort at different points in time to familiarize the international community with the prevailing circumstances on the ground.

Albeit Ethiopia's stance is a bitter pill to swallow for them, worrywarts have maintained disseminating their usual fake news stories throwing the cold shoulder to the existing situation on the ground.

Taking the aforementioned facts on the ground, the various print and electronic media outlets of the country should play a paramount role in bringing into the light the international community as a whole with Ethiopia's self-evident truth.

The current Memorandum of Understanding (MoU) that Ethiopia has signed with Somaliland is a critical move that would expedite trade and commerce in the

east African region, UNESCO Chair on International Water Cooperation Ashok Swain in the recent past said.

The MoU for Partnership and Cooperation inked by Ethiopia and Somaliland includes wide scopes of cooperation in social, economic, political, and military fields.

The memorandum is also intended to serve as a framework for the multispectral partnership between the two sides, and shall pave the way for realizing the aspiration of Ethiopia to secure access to the sea and diversify its access to seaports.

Speaking to local media, Swain stated that access to sea is imperative particularly for Ethiopia, which has been striving to become a regional economic powerhouse in recent years.

According to him, Ethiopia is also one of the sizable economies in the Sub-Saharan African region and also has growing population.

In particular, the UNESCO water cooperation chair pointed out that the MoU to get access to seas is extremely sensible as Ethiopia has an increasing number of population, strategic importance and economic growth.

"Ethiopia needs much more opening to sea and I think Somaliland is a good step in that direction," he said.

Most importantly, Swain stated that the MoU is important because it would open up the Red Sea for maximizing trade and commerce activities in this significant part of the global trade route.

The deal is also highly anticipated to accelerate regional integration and will enable countries in the region to develop together, he elaborated.

Trade and commerce are very important things not only for the development of a particular country but for regional economic integration.

As long as Ethiopia does not have an inkling of harming any nations, all stakeholders should stand by the side of the country to expedite the implementation of the memorandum of understanding signed between Ethiopia and Somaliland at the earliest possible time.

As the deal plays a huge role in taking the region to the next level of accomplishment at the earliest possible moment, pertinent bodies should play a part in assisting the progress of economic integration.

It appears clear that if all stakeholders stand in unison, taking the promising moves into account, the region can prosper together just around the corner.

# Industrial park showcasing Chinese extensive investment participation in Ethiopia

Ethiopia's peace and stability, effective activities carried out in the field of infrastructure development, incentives for the investment sector, as well as the country's potential natural resources and wide market opportunities, have allowed it to become one of the leading countries in Africa in terms of attracting Foreign Direct Investment (FDI). This has played a typical role in the development of the investment sector and has contributed a great deal to the country's economic growth.

The country's investment sector is one of the sectors that have constantly achieved great progress and growth. However, in the past few years, the security problems created in different parts of the country, combined with the global COVID pandemic, economic crisis, and wars, had an impact on the country's investment activities.

Gladly, various measures taken by the government have allowed the investment sector to revive. The Ethiopian Investment Commission (EIC) has stated that the problems that have put pressure on the investment sector are being solved step by step. For example, in the last fiscal year, it was possible to attract 3.82 billion Dollar of FDI. 329 new investment licenses were issued. 115.2 million Dollar of foreign currency was obtained from all industrial parks. MoU's have been signed with 70 companies that have shown interest in entering industrial parks. Monitoring and inspection activities have been carried out on 205 projects located in nine industrial parks.

Taking into consideration the current national and international situation and protecting the country's interests, revisions of bilateral investment agreements have been completed and new negotiations have been made. Preparations have been made to benefit from new regional trade and investment opportunities.

Ethiopia's investment potential and good opportunities have been introduced at many international investment forums and exhibitions. In addition to this, it is planned to attract 4.5 billion Dollar of FDI in this fiscal year and to issue new investment licenses for 341 projects (excluding industrial parks).

As efforts to increase investment continue, Foreign Direct Investment is on the rise. The number of domestic and foreign investors entering industrial parks has increased significantly. Organizations engaged in investment activities are contributing significantly to product growth, foreign exchange earnings, job creation, and technology transfer and market linkages.

The development of Industrial Parks is one of the activities that have been given attention that will contribute to the realization of Ethiopia's structural economic transition. Industrial parks have the main fundamental missions of attracting FDI, expanding job creation and realizing technology transfer. The parks will contribute greatly to the national economic development by creating jobs for the community living in the areas where they will be built and creating a working environment that is suitable for the environment.

In addition to the 12 industrial parks built by the government and managed by the Industrial Parks Development Corporation and regional governments and the Diredawa Free Trade Zone, there are also industrial parks built and managed by private investors in various areas of Ethiopia. One of these private industrial parks is Eastern Industry Park. The industrial park is located in Dukem area, and 153 companies are engaged in production activities in the park. 95% of the companies are owned by Chinese investors, while the rest are owned by companies from India, England, and other countries. These producers are contributing significantly in terms of job creation, foreign exchange earnings, technology, and knowledge transfer.

One of the factories in the park is Di Yuan Ceramics. The manager of the factory, Xu Bo, pointed out that the factory was established seven years ago with an investment of 50 million Dollar, and said that it produces wall and floor ceramic products. It has created job opportunities for 800 Ethiopians and 50 Chinese. They also explain that Ethiopians are benefiting from the transfer of skills and technology. The manager also said that the support of the government has contributed greatly to the improvement of the factory.

According to David Zhou, General Manager of "Huajia Aluminum Industry PLC", the factory started working eight years ago with an investment capital of 181 million Birr and has created job opportunities for more than 170 Ethiopians. The factory has produced 16 types of aluminum profiles and is supplying them to the domestic market.

He explained that the investment of the factories in the industrial park will strengthen the Ethio-China economic ties and the good relations between the two countries are contributing to the efficiency of the factories. He stated that the Ethiopian Investment Commission has been supporting the factory from the beginning and that the factory works in cooperation with the local community, the state and the federal governments.

On his part, Jay Yifan, General Manager of Linde Ethiopia Garment PLC, pointed out that the factory manufactures and markets different brands of textile products. More than one thousand Ethiopians are employed in the factory.

The Deputy Commissioner of Industrial Parks and Promotion of the Ethiopian Investment Commission, Zeleke Temesgen (PhD), said that "Eastern Industry Park" is the first among the private industrial parks in Ethiopia. According to him, the manufacturers in the park are contributing significantly to job creation, export trade and foreign exchange earnings. Most of the production work in the factories in the park is carried out by Ethiopian experts. This indicates that the skills and technology transfer plan is well underway. Apart from this, foreign investors are working with domestic investors.

According to Zeleke (PhD), there are currently 3309 Chinese investment projects in Ethiopia with a capital of more than 8.5 billion Dollars. These projects have created job opportunities for more than 325,000 citizens. Chinese investors are playing a leading role in the number of investment projects, capital capacity, job creation, and technology and knowledge transfer.

The deputy commissioner explained that the economic reform measures taken in the investment sector are contributing to accelerating the development of the sector. According to him, the Investment Proclamation has been amended in a manner that can increase the flow of investment. Proclamation of Special Economic Zone was also approved. Following this, the commission prepared guidelines and started working.

Stating the procedures implemented by the complete macro-economic reform will create favorable investment opportunities for foreign and domestic investors, Dr. Zeleke said that the investment flow in the first three months of this fiscal year has increased by 12% compared to the same period of the previous fiscal year.

Measures taken to make the investment climate more conducive have contributed to this growth. One of the tasks of the commission is to monitor and support investors. He also explained that the monitoring and support activities will help investors to expand their businesses and other investors to come to Ethiopia.

"Currently, Ethiopia is the primary foreign investment destination in East Africa. In spite of this, there are many things that need to be done to attract more investments in terms of Ethiopia's potential. The potential of the country, combined with the economic reforms being undertaken by the government, will enable it to become a preferred investment destination at the international level. The flow of investment in various sectors is increasing significantly. Especially in the sectors identified as strategic (manufacturing, agriculture, information technology, mining, tourism), a high investment flow is being seen," he said.

Dagato Kombe, Deputy Commissioner of the Ethiopian Investment Commission, said that the country's potential investment capacity and the government's economic reform measures are among the reasons for the increase in investment flows. According to Dagato, the economic reform measures will create opportunities for investors to come to Ethiopia and engage in investment.

"When the investors come from abroad, they consider different options. And we have to offer a better option to attract the investors. One of the queries from investors is the lack of foreign exchange. The foreign currency is very important to purchase raw materials and to meet other inputs. Promising beginnings are being seen that the recently implemented foreign exchange management reform will contribute to easing the shortage of foreign exchange," he said.

As to him, one of the measures taken to improve the investment environment is the opening of business sectors that were previously closed to foreign investors. With this, it was decided that foreign investors should engage in expenditure, import, wholesale, and retail business activities.

Since July 2024, 72 requests have been submitted following the decision. Out of these, 41 are requests for participation in import and 31 are for participation in export. Among the 22 companies that submitted proposals, the requests of 12 companies were approved by the Ethiopian Investment Commission. Eight Chinese companies are among those whose requests were approved.

### Ethiopia takes action to combat the looming threat of sound pollution

The environment is facing unprecedented challenges due to climate change, pollution, and unsustainable practices. It is human activities that improve their lifestyle, but there is no one to take responsibility to protect our planet for future generations. In a recent press briefing, Dida Driba, General Manager of the Addis Ababa Environmental Protection Authority, stated that the significant measures taken to combat environmental pollution in the city. In the first quarter of the 2017 E.C. fiscal year, action was initiated against around 701 institutions identified as contributors to environmental degradation.

He mentioned that over the past three months, monitoring efforts were expanded to include 2,316 institutions. The proactive inspection aimed to bolster the city's efforts in controlling pollution, especially in densely populated areas where industrial and residential overlaps often lead to environmental challenges, he said.

A primary concern highlighted by the General Manager is noise pollution, which has been a recurring complaint among residents. To address this, four expert teams were deployed to evaluate more than 200 households, identifying sources of excessive noise. As a result, warnings were issued to those found violating noise regulations.

In addition to noise complaints, the authority received over 190 petitions from

the community regarding various pollution issues, with noise being the most frequently mentioned. He also emphasized the importance of community involvement in the fight against pollution, acknowledging that public awareness is crucial for sustained environmental protection.

For fostering environmental awareness among the Communities must be informed about the causes and effects of climate change, waste pollution, and sound pollution. Schools, local organizations, and community centers can host workshops, seminars, and informational campaigns

to educate residents about these issues. Providing accessible information empowers individuals to make informed choices in their daily lives.

He expressed confidence in the effectiveness of the pollution prevention initiatives launched in the last six months, noting that these efforts have significantly raised public awareness about environmental issues. "The environmental pollution prevention movement will continue to be a regular activity," he assured, indicating a commitment to ongoing monitoring and action.

Technology will play a crucial role in future initiatives, as Dida explained that various technological supports are being integrated into pollution control measures. The approach aims to enhance the efficiency of monitoring and enforcement, making it easier to identify and address pollution sources in real-time, he said.

Organizing community events such as cleanup drives, tree planting, and sustainability fairs can engage residents and promote a sense of collective responsibility. These events not only beautify neighborhoods but also provide hands-on experiences that reinforce the significance of caring for the environment. # $Gamo\ Dubusha$ : The Indigenous culture as an exquisite community administration

In examining a given nation, the cultural asset of that nation takes the greatest share. African people have been unique in preserving their indigenous cultures for centuries. These artistic practices did carry the potential, efficacy and intelligence of the people. In the cultural portrayal of a given nation, the philosophy, belief, and mental excellence of the people are mirrored through it. Thus, since these artistic practices are exhibited as per the identity and context of the holders, it is logical to say that these cultures are also opportunities to be used for transforming and advancing the people.

Ethiopia embraces a variety of cultural identities that coexist with harmony and peaceful cooperation. Among these cultures, Gamo people who are located in the southern part of the region are the ones that have their own impressive culture and values. In the area where one needs to raise the culture of these people, *Dubusha* takes the highest share.

Dubusha is the most adored and respected notion in the people of Gamo. It is the term that conveys the who of the people's identity and culture. Everything in the area is connected with it. Thus, what does it mean? ...was the interest of *The Ethiopian Herald* crew? We ran to the area and contacted the scholars and elders. We also noticed some practices in person.

Tafesse Welea, Community Service Coordinator at Social Science and Humanities College of Arba Minch University, is a researcher who has been studying the culture of *Dubusha* and from the culture too. He had an exclusive interview with *The Ethiopian Herald*.

I picked up the term *Dubusha* and asked him to explain it to begin our conversation. He said, "*Dubusha* did mean meeting. The coming together of people to discuss any issue which can be done anywhere is

Dubusha. But in the issues that commonly concern the given Derie or culturally portioned region, the meeting place is already assigned by the people. And that place is called *Dubusha*." The researcher further explained that the people of Gamo had been administered by the cultural and indigenous knowledge of the elders that they received it from generations.

The background of the Indigenous knowledge that these people cultured to peacefully administer their regions or Deries is the orally transmitted mythology. As Tafese said, this mythology dictated that when the people of Gamo quarrel and suspicion occurs among themselves, then the Holy Spirit send a rule and regulation to the people to be respected. It affirms that the community should live peacefully and respectfully; otherwise, something bad could happen to them and their generations. This mythology then excels from generation to generation. Though the tendency and the magnitude of its application are slightly varied across Deries, the major cultural rudiments are still prevailing in the community as a whole.

"Dubusha, at the given community is going to be prepared based on some necessities. These are the place should be positioned on the top surface of the given village." As Tafesse explained the reason for making this is to make it visible to the community. In addition to that, if it is placed on the top area, it is possible to view the natural settings that are very relevant during the oath process of the suspect who finally gets up there. That is at this top place it is possible to see the mountain, the graves, the trees, and the elders that could face the person in that setting. The next thing to be considered is the place should be eclectic and plain. This is deliberately done to make it comfortable and accommodating.

Dubusha can happen at the family level. The pillar of the house is the husband or the elder male section in the family. Thus, this man can bring the family members together

and discuss issues that happened in the house or could narrate about the culture to the family. This is *Dubusha*. But if there is a community -concerning issue then it could be taken into the meeting place *Dubusha*. This culturally believed judgment place is assumed a sacred place. Thus it is a highly respected and preserved area.

Dubusha in a given Derie or cultural region is recognized as the place where fair and sound justice is delivered for the community equally. At this type of **Dubusha**, lots of cultural events take place. Since the people are administered by cultural leaders or *Halekas* and *Hudugas* and on toplevel *Kawos*, these power transitions and appointments had been taking place at this place.

Kawo Tadess who is the top leader or king of Deries, told to Herald the following. "Dubusha is the most adored and blessed place in the eyes of Gamo people" as he asserted any case that the community faced in their life, they brought to Dubusha and there are appointed leaders that are responsible for cases as per their subject. Then a responsible leader or Haleka, could try to solve the raised issue after a cautious and fortitude hearing and understanding of the issue from the community. Though there are top leaders over the given Haleka, no one could try to interfere in the power exercising right of the given leader.

While I was at Dita to contact the cultural leader of the area, I was directed to the Culture and Communication Office of the area by Zone department. When I got there, the legal cultural office leader was waiting for me. I talked to him and asked him to call the cultural leader. Then a very old and gorgeous man with cultural decor wearing style and with half metal made stick arrived. In the office, the officer introduced me to him and invited him to sit on the officer's chair. But this old man refused. I said why. He said, "That is not my chair and responsibility. I have my own place to sit. In this context, I am a customer not a leader

at this place." Then the officer took us out to the area's meeting place or *Dubusha*. There, this old man plugs in his stick and sits on the bench made from stone.

Tafesse mentioned that, unlike the modern procedure in courts, cases that happened in the community of Gamo are not expected to have evidence. If there is evidence, it is good and could be used to help the criminal confess his deed. But in the culture of Gamo people, the steps they follow to solve problems and make judgments are quite different. For whatever wrong did happen in the area, the suspect is simply called and asked for the issue.

In Gamo zone even before the legal procedure was seen in court, the people were managed by their indigenous knowledge and culture. This cultural administration had its own system and hierarchy. Issues are uniquely headed by a particular leader or Haleka. For instance as the approached elders assured there is one leader or *Haleka* that is responsible for the preservation and management of Dubusha, and there is another Haleka that takes care of the preservation of indigenous plants and so on. On top of them, there is a top leader called *Huduga*. All the Halekas take care of their responsibility. If things go beyond their scope, they could bring it to Dubusha and call Huduga for top decision. The *Hudugas* again are led by a top leader called *Kawo*. This *Kawo* is responsible for heading more Deries or Hudugas. Though he is the top leader, he never interferes with the responsibilities of Hudugas. He could avail himself if there were cases that needed his confirmation.

This hierarchy and cultural administration have been there in the area for centuries. Thus, the people are very respectful and cooperative when approached by their elders. Therefore, this asset could be used as an opportunity to ensure togetherness and complementarity between people in the country and the continent too. Our indigenous identity, I believe is the best way to achieve our prosperity goal.

According to him, the Africa Hall is emblematic of Africa's past struggles and triumphs when the OAU Charter was signed right here in 1963 - a signal for a new beginning, he said, adding that "Now, more than ever, it makes a sound economic sense to invest in sectors like tourism that harness our history, culture, and heritage, to mobilize resources for national and continental development."

He mentioned some of the world's iconic landmarks such as China's Great Wall, America's Statue of Liberty, France's Eiffel Tower, and India's Taj Mahal, providing practical examples of how history and culture can draw millions of visitors annually, and also contributing to shared prosperity.

Efforts have been made to meticulously

preserve the materials from the original 1961 construction, blending the past with the present to create a rejuvenated space that reflects Africa's proud heritage.

The hall now stands as a modernized facility, equipped with state-of-the-art amenities, a visitors' center, and permanent exhibition space and conference hall to host high-level meetings, while maintaining its architectural and historical significance.

One of the standout features is the open design of its chamber - an intentional homage to Emperor Haile Selassie, who believed that critical discussions should not be held behind closed doors.

"Sixty years ago, visionary leaders gathered in this very hall to lay the foundation for African unity by signing the Charter of the Organization of African Unity, he stated underlining that "When the next generation gathers here in the decades to come, it is only right that they should be inspired by the efforts we make today to advance the cause of Africa's transformation."

## Reasserting Ethiopia's bid to host AFCON 2029

he fact that Ethiopia has made a serious and official bid to host the African Cup of Nations (AFCON) 2029 implies that it is committed to fulfilling all the required preconditions and making them a success. It is great news for the millions of devout Ethiopian football fans and for those who want to see their country in the spotlight of not only the African community but also in the larger international arena.

Ethiopia is a founding member of the Confederation of African Football, CAF, and it has hosted the tournament twice in the past, once in 1962, and the second in 1976. It is now almost half a century since the country last hosted this prestigious continental showpiece. As one of the most prominent states of Africa and a founding member of CAF and the African Union as well as the seat of the AU Commission, one would expect it to host the AFCON's more than two times in more than thirty runs. Of course, to be able to host such events there are certain preconditions such as the necessary infrastructure, up-to-standard sporting facilities such as stadiums and training grounds with the necessary accessories, hotels and transportation amenities besides of course a real sense of peace and security in the country that bids for staging the tournament. In this sense not always was Ethiopia up to the highest standards even if its reputation as a wonderful venue for international conferences including the yearly AU heads of state and government summits may be intact.

The truth is that not all its sporting facilities were of the best types and FIFA and CAF are pretty exigent on these specific points. In the past, we have seen Egypt having the privilege of hosting the tournament multiple times because of its ever-ready sporting venues. Other countries such as Ethiopia did not have similar chances because of some conditions lacking. This time however it seems that the government is fully committed to meeting all the demands of the CAF and that is why the bid is serious and it has come from the mouth of Prime Minister Abiy Ahmed and has been endorsed by President Taye Atske Selassie.

Ethiopia is now in a position to prepare and stage the 37<sup>th</sup> edition of the event 'AFCON 2029'. This means that it has four years to finish all the outstanding conditions that CAF may be posing, such as finishing well with the preparation of all the venues and facilities in time and proving that there is the right socio-economic climate that facilitates the smooth success of the event.

Providing adequate transport facilities along with the up-to-standard hotels in all the venues is another requirement, and in this regard, the reputation of Ethiopian Airlines is more than a guarantee as it is a worldwide trademark in its own right and would accommodate all requests for transportation not only from outside to Ethiopia but also

internally, following the potential demands of movements of expected large crowds of fans anxious to attend the matches.

Sport is one of the most significant social activities in this world today also because it has become a huge industry and an immense economic phenomenon. There are very big international companies that compete between themselves to sponsor huge international sporting events and contests. Ethiopia is one of the founders of the Confederation of African Football, CAF, in 1957 and had in the person of Yidnekatchew Tessema in the lead of this body for years. Countries which otherwise would hardly be spotted on the world map have managed to be huge powerhouses due to their athletes' brilliant exploits.

It was Prime Minister Abiy Ahmed who showed around the progress this stadium was undergoing and would definitely be ready for the AFCON 2029 along with several others which are in the final stages of completion trying to fulfill all CAF standards.

This event would definitely be a significant boost to Ethiopia's image as a successful with dynamic development and progress. This would be a further stimulus for the economy to continue with the current trajectory and pace and dismiss all the negative rhetoric forwarded against Ethiopia. Forces that do not want Ethiopia to succeed may try to dismiss its efforts to assert certain reasonable and legitimate rights through diplomatic means and secure access to the Red Sea waters. They may also object to its legal sovereign rights to harness the water of the Nile by constructing the Grand Ethiopian Renaissance Dam, GERD which by the way is also a huge expression and demonstration of sovereignty.

No wonder it's joining of the BRICS community is also another stimulus in its ride towards new frontiers in the world at large giving priority more to its national interests rather than being constrained by committing to partisan political or ideological divisions.

Ethiopia hosting the AFCON 2029 would have the golden opportunity to show to the world that it is a growing country in all aspects, a 'land of origin' and successful not only economically and socially but also diplomatically.

As the sport has been a huge locomotive of change and growth, governments are now giving it more attention than in the past. The sport also contributes to forming a new generation of healthy youths trying to emulate the successful ones. There is a certain frustration that African footballers have not had the recognition they deserve because of the poor results they record in world competitions. It was only two years ago in Qatar that an African national football team managed to reach the last four in the World Cup! But this does not show the real potential of Africa. It has so many excellent players who contribute to the strength of European football teams. These players not having ideal conditions at home are destined to migrate to Europe. The next ambition of any African team must be to win the World Cup and if the right planning and execution is carried out it would not be impossible to reach that goal soon. In the meantime, Ethiopia may register a huge breakthrough if it manages to conquer CAF's green light to host AFCON 2029. This opportunity is now nearer than ever before.
